SUB : F.I.R.

Respected Sir,

I, ANJALI GUPTA, W/O Chandan Kumar, D/O Shambhu Prasad Gupta, Presently residing of Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, I do here by want to inform you as follows :-

1. That I lodge this F.I.R to the effect that on 20.01.2016, I was married to Chandan Kumar, S/O Badri Prasad Gupta, presently residing at Jagdamba Nagar, Kollua Paiganberpur, P.S. Ahiapur, Dist. Muzzaffarpur, in the State of Bihar.
2. That during the marriage negotiations, my husband and my in-laws demanded cash dowry of Rs. 10,00,000/- from my father, and my father has given the cash dowry of Rs. 7,00,000/- (Rupees Seven Lakh Ten Thousand Only) to my husband and my in-laws . Moreover, Bed, Dressing Table, Godrej, Television, utensils worth Rs. 2,50,000/- (Rupees Two Fifty Thousand), which has been handedover to my husband and my in-laws presence of the other relatives.
3. That soon after marriage my husband started to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply his demands my husband, my mother-in-law namely **BIMAL DEVI**, father-in-law namely **BADRI PRASAD GUPTA**, brother-in-law namely **MITHILESH KUMAR**, all are resident of Jagdamba Nagar, Kollua Paiganberpur, P.S. Ahiapur, Dist. Muzzaffarpur, in the State of Bihar, started to torture me, beat me mercilessly and used abusive languages upon me.

4. That my husband along with his other family members as mentioned above always used to humiliate me in all respect and in spite of fulfilling all their dowry demands my husband was never happy with me and always used to taunt me as I had brought insufficient dowry. I was treated like a servant from the very beginning and not given the status of a wife. I was bearing all the torture of my husband with a hope that everything will be alright in future but everything was in vain.
5. That thereafter my husband after few months of my marriage went to Delhi for work and started to reside there and when ever I called my husband over phone he used to abuse me in filthy languages and continuously threatened me and told me to give divorce to him and when I used to protest then he used to abuse me and disconnect the call.
6. That subsequently out of our wedlock one male child namely Medhansh Gupta was born on 28.09.2016. After the birth of my Son I thought that everything will be alright but all are in vain.
7. That thereafter my husband return from his work after birth of my child and started to torture me day by day upon me as well as upon my minor child but I tolerate all the torture with a hope that everything will be alright in future. Moreover after passing of time I revealed that my husband is in extra marital relationship with a women, and due to this my husband mostly used to stay out of his house upon the excuse of his working purpose and when I tried to ask him about his absence my husband got furious and started to beat me and my minor child mercilessly, also threatened me. Most importantly my husband frequently met her extra marital affair and used to stay outside for late hours and when I objected the same my husband clearly stated that they love each other and they will kill me and my minor child and bury my body and my child's body and will marry with each other.

8. That my mother-in-law also used to beat me and my minor child when I protested against these kind of illegal activities of my husband and my mother -in-law also abused in filthy languages and pulled my hair dragged on the floor and continuously taunted me for bringing less dowry.
9. That whenever I protest against my husband's illegal activities and his extra marital affair my husband used to beat me, have forceful sexual intercourse with me and not even provide sufficient food and other necessities to me and my minor child.
10. That thereafter my husband started to give me some medicines forcefully with an intention to make me mentally imbalance. Moreover when my husband got furious and by using force pushed my head towards the wall with an intention to kill me, pressed my neck and pulled my hair and forced me have sexual intercourse with me by putting knife on the neck of my minor child.
11. That in the year 2019 my brother-in-law got married with one lady namely Sakshi Gupta and after their marriage my younger sister-in-law also started to torture me mentally and treated me like her servant and my -in-laws appreciated her on this and her torture also increased day by day.
12. That on 03.12.2021 my husband and my in-laws continuously forced me to bring more money from parents for the construction of their new house and when I protested for the same my mother and father in -law used to beat me and used abusive languages on me and when I protested then my in-laws used to cover my face with hands and cloth tied me with a rope inside the room and and all my family members used to beat me mercilessly.

13. That thereafter my in-laws mostly used to lock me inside the room with my minor son and whenever I used to shout then my husband used to beat me more mercilessly and slapped me scratched my face, kicked my minor child with an intention to kill my minor child and strangled me and forced me to give him Divorce and when I refused to it then he used to bang my head on the wall. Moreover my husband always used to have forceful sexual intercourse with me by putting my minor child on the fear of death.
14. That thereafter recently on 06.12.2021 my mother-in-law started to throw me outside the house by pulling my hair and dragging me on the floor and started to shout that my husband is not my husband and abused me in mostly filthy languages and when again I protested on this then my husband and my in-laws again locked me inside the room and slapped me tied me with the rope and started to beat me mercilessly by covering my mouth with the hands and after that they left me inside the room in starving and painfull conditions and I lost my sense and they left me by assuming me that I died.
15. That thereafter when I regain my sense then I started to shout and scream then my husband forcefully brought me to Siliguri with the threatening he will Divorce me and will marry another lady and my husband after bringing me at Siliguri again thereatened me and took me Hotel and thereafter out of fear I somehow managed to call my family members and thereafter they took me the Siliguri District Hospital for my treatment.
16. That at present I am living in very depressed condition and became mentally and emotionally ruined due to the above mentioned cruel acts and conducts of my husband, my mother-in-law namely **BIMAL DEVI**, father -in-law namely **BADRI PRASAD GUPTA**, brother -in-law namely **MITHILESH KUMAR**, sister-in-law namely, **SAKSHI GUPTA** all are resident of Jagdamba Nagar, Kollua Paiganberpur, P.S. Ahiapur, Dist. Muzzaffarpur, in the State of Bihar and I am in very much fear that my husband and the other family members may kill me and my son and may remarry the another lady with whom my husband is having the extra marital affair.

I therefore request before your good self to kindly look into the matter and take strict necessary action against my husband Chandan Kumar, my mother-in-law namely **BIMAL DEVI**, father -in-law namely **BADRI PRASAD GUPTA**, brother -in-law namely **MITHILESH KUMAR**, sister-in-law namely, **SAKSHI GUPTA** all are resident of Jagdamba Nagar, Kollua Paiganberpur, P.S. Ahiapur, Dist. Muzzaffarpur, in the State of Bihar, as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
