I PSI Youel Lepcha Of Pradhannagar Police Station, SPC would like to lodge this written complaint against the above noted arrested accused person vide PS GDE No-684 dated 12.12.2021 to the effect that on 12.12.2021 in course of special van duty being accompanied with C/1416 Dilip kr Barman and C 704 Ratan Rai received a complaint from local people over telephone that the loud music (DJ Music) has been playing at Pradhan nagar Patel Road area, therefore I inform the matter to you and as per your kind order myself along with force had been to the Spot and found music is being played loudly by the person then I directed him to stop the DJ Music immediately but he didn't pay any heed. Having no alternative I seized the above noted seized musical instrument with proper seizure list and arrested the above noted person U/S 41 Cr.P.C for violation of order of Hon'ble High court.

Under the above circumstances I pray that a specific case may kindly be started against the arrests Bishnu Sah (24) S/O Megnath Sah of Hanuman mandhir Coollipara P.S Pradhan nagar Dist Darjeeling under proper section of law and arrange for its investigation.
