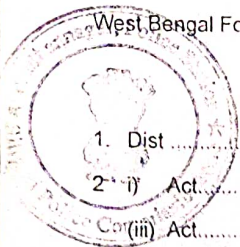

Particulars of properties stolen 20(Twenty) bottles of ONEREEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", each bottles contains 100 ml which contains Codeine Phosphate 10 mg each, kept in one White & yellow Colour bag, Styles as DHARMA RAJ, marked as Exhibit -"A", ii) 54 (Fifty four) strips of "Paracetamol Dicyclomine Hydrochloride & tramadol hydrochloride Capsules" Spasmaxx, capsules, which each capsules contains Tramadol Hydrochloride IP 50 mg, each strips contained 08(Eight) capsules and marked as exhibit "B", iii) 01(One) bottles of ONEREEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", contains 100 ml which contains Codeine Phosphate 10 mg randomly taken from exhibit "A" for examination and marked as exhibit. A-1, iv) 01(one) strips of "Paracetamol Dicyclomine Hydrochloride & Tramadol Hydrochloride Capsules" Spasmaxx, capsules, which each capsules contains Tramadol Hydrochloride IP 50mg, contained 08(Eight) capsules randomly taken from exhibit "B" and marked as exhibit- B-1, v) 01(one) White & yellow Colour bag, Styles as DHARMA RAJ, marked as Exhibit -"C"

Sir,

In producing herewith two arrested accused persons namely (i) Asgar Ali (42) S/O Lt Barkat Ali of Dangipara, Ward No.6, P.S-Siliguri, Dist. Darjeeling & (ii) Arun Jha (41) S/O Lt Mohan Jha of Gurung Busty, near Mahamaya Kali mandir, P.S. Pradhannagar, Dist Darjeeling and the following property under seizure along with seizure list:-

- (i) 20 (Twenty) bottles of ONEREEEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", each bottle contains 100 ml which contains Codeine Phosphate 10 mg each, kept in one White & yellow Colour bag, Styles as DHARMA RAJ, marked as Exhibit - "A"
- (ii) 54 (Fifty four) strips of "Paracetamol Dicyclomine Hydrochloride & tramadol hydrochloride Capsules" Spasmaxx, capsules, which each capsule contains Tramadol Hydrochloride IP 50 mg, each strip contained 08 (Eight) capsules and marked as exhibit "B",
- (iii) 01 (One) bottle of ONEREEEX cough Syrup "Chlorpheniramine Maleate & Codeine Phosphate Syrup", contains 100 ml which contains Codeine Phosphate 10 mg randomly taken from exhibit "A" for examination and marked as exhibit- A-1,
- (iv) 01 (one) strip of "Paracetamol Dicyclomine Hydrochloride & tramadol hydrochloride Capsules" Spasmaxx, capsules, which each capsule contains Tramadol Hydrochloride IP 50mg, contained 08 (Eight) capsules randomly taken from exhibit "B" and marked as exhibit- B-1
- (v) 01 (one) White & yellow Colour bag, Styles as DHARMA RAJ, marked as Exhibit - "C"

I, ASI Ashit Singh, of Pradhan Nagar PS Siliguri Police Commissionerate do hereby submit this written complaint against above noted accused persons to the effect that on 13.12.2021 at 17.55 hrs, I received a reliable source information that two persons namely Asgar Ali & Arun Jha standing at S.N.T bus stand, Siliguri Junction under Pradhannagar PS with huge consignment of contraband cough syrup & Capsules for selling the same said area.

The matter has been diarized vide Pradhan Nagar PS, GDE No. 749 Dt- 13.12.2021 and I informed you and as per your direction myself along with, ASI Debasish Das, ASI Tarun Kanti Ghosh CV/646 Baban Ch Das, CV/223 Swapan Chettri CV/128 Ajay Kr Sahani all of Pradhan Nagar PS Siliguri Police Commissionerate left for SNT Bus Stand by Govt. vehicle bearing no- WB-74AC 9851 to verify the veracity of the information accompanied by my source. This refers to Pradhan Nagar PS M.C.C No. 2712/2021 Dt. 13.12.2021 which refers to Pradhan Nagar PS GDE no. 751 Dt- 13.12.2021.

At the time of departure from the office, I took investigation kit and all necessary equipments. At about 18.20 hrs, we arrived near S.N.T bus stand, Siliguri Junction under Pradhannagar PS and I contacted with two local people and found two respectable persons namely (i) Sri Amit Upadhaya (42) S/O Sri Narshu Narayan Upadhaya of South Baghajotin Colony, Ward No.02, PS Pradhan Nagar Dist. Darjeeling & (ii) Sri Rupak Mondal (32) S/O Lt. Mantu Mondal of Gurung Busty, neemtala, Ward No.3. Then I informed them about the information in hand and requested them to accompany us in the whole process of search and seizure if necessary and as pointed by the source we found that two persons standing at S.N.T bus stand with one bag. Accordingly, we apprehended them. On being asked the apprehend persons disclosed their identity as noted above. On further asked about the contents of their bag, they stated that its contains cough syrup & Capsules for supply the same at Gangtok, Sikkim through Customer.

Then we detained them with strong reason to believe that the said persons is illegally possessing & selling the contraband cough syrup & Capsules inside their bag . After disclosing our identity, I asked them in writing, whether they wants to be searched for presence of Executive Magistrate or Gazetted Officer for the process of Search and they agreed to be searched by any one

of the two. Subsequently, I contacted to the Sri Subhashis Chaki ,I/C Pradhannagar PS SPC and requested to come to the spot and supervise the entire process of search and seizure as per law. Sri Subhashis Chaki, I/C PS SPC arrived at the spot at 18.55 hrs. He discloses his identity before apprehended persons as gazette officer and he has been offered to search the police team as well as gazetted officer and witnesses, but they refused. Thereafter the process of the search was started.

Then, as per direction and under supervision of Sri Subhashis Chaki, I commenced search the bag from their joint possession and found above noted contraband cough syrup & Capsules . On asking they failed to produce any valid documents in support of the contraband cough syrup. Then I seized the above noted articles, throughout the sealing and labeling by preparing proper seizure list. The entire search, Seizure, label process has made between 19.15 hrs to 20.25 hrs. and arrested the apprehended persons namely i)Asgar Ali(42) S/O Lt Barkat Ali of Dangipara, Ward No.6, P.S-Siliguri, Dist.Darjeeling & (ii)Arun Jha (41) S/O Lt Mohan Jha of Gurung Busty, near Mahamaya Kali Mandir , P.S. Pradhannagar, Dist Darjeeling for violating NDPS norms after maintaining all formalities regarding arrest.

In the above circumstance, I pray before you to take the seized articles and sample & arrested accused persons namely i) Asgar Ali(42) S/O Lt Barkat Ali of Dangipara, Ward No.6, P.S-Siliguri, Dist.Darjeeling & (ii)Arun Jha (41) S/O Lt Mohan Jha of Gurung Busty, near Mahamaya Kali Mandir, P.S. Pradhannagar, Dist Darjeeling and started a specific case against the arrested accused person under proper section of law and arrange for its investigation.
