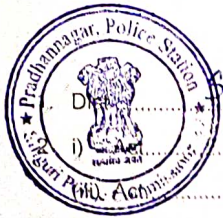

- 4) one sound mixture for sound system.
- 5) One Dynatec V-5000 Amplifier of sound system.
- 6) One Tata Ace vehicle reg.no. WB73E/8292.

I SI.Haren Mohanta Of Pradhannagar Police Station, SPC would like to lodge this written complaint against the above noted arrested accused person vide PS GDE No-721 dated 13.12.2021 to the effect that while I am performing night mobile van duty on 13/14.12.2021 accompanied by C/1411 Ashok Roy and C/473 Amrit Sarkar. At about 00:05 hrs received complaints from local peoples over telephone that the loud music (DJ Music) has been playing on the road in a small vehicle through Darjeeling more under Pradhan nagar Ps area, I inform the matter to you and as per your kind direction myself along with force had been to the Spot and found a small vehicle carrying DJ music system and is being played loudly by the person then I directed him to stop the DJ Music immediately but he didn't pay any heed. Having no alternative I have seized the above noted musical /sound systems with proper seizure list and arrested the above noted person U/S 41 Cr.P.C for violation of order of Hon'ble High court.

Under the above circumstances I pray that a specific case may kindly be started against the arrests Bikram Kumar Singh(26) S/O Janardan Singh of Durganagar, W/No.4, Ps. Siliguri, Dist-Darjeeling under proper section of law and arrange for its investigation.
