Sir,

I, ASI Nitai Mandal of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Sanjoy Saibo (34/M) S/O Lt. Sunilal Saibo of Nimajote, P.O- Nimai, P.S- Matigara, Dist.- Darjeeling under arrest along with following seized articles viz ; 1] 10 (ten) bottles of Kingfisher Strong premium Beer each bottle containing 650ml and marked as 'exhibit - A' and 2] 01 (one) bottle of Kingfisher Strong premium Beer containing 650ml taken from "Exhibit-A" for examination and marked as "Exhibit-A-1" under seizure list (which is enclosed herewith) to the effect that on 18.12.2021 at 20.35hrs received a secret source information that one person Sanjoy Saibo (34/M) S/O Lt. Sunilal Saibo of Nimajote, P.O- Nimai, P.S- Matigara, Dist.- Darjeeling has stored huge quantity of Illicitly liquor at his house without any valid license. Diarized the matter vide Matigara PS GDE No.906 Dt- 18.12.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with Const- 1035 Santosh Rabi Das, CV- 155 Sukumar Das left for Nimajote under Matigara P.S to verify the veracity of the source information. On reaching at the spot at 20.55 hrs it was found that huge quantity of illicit Liquor stored in the house of Sanjoy Saibo who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Sanjoy Saibo. There after I called two independent witnesses of that locality namely i) Monojit Saibo S/O Amit Kumar Saibo and ii) Anand Saibo S/O Lt. Mishra Saibo, both of Nimajote, P.O- Nimai, P.S- Matigara, Dist.- Darjeeling and in the very presence of those witnesses I search the house and seized illicit Liquor after preparing proper seizure List duly signed by the two independent witnesses and apprehend the person namely Sanjoy Saibo. On being asked the said person failed to produce any document for selling and storing of illicit Liquor at the house. It's a violation under Bengal Excise Act. This seizure was made on 18.12.21 in between 21:05 hrs to 21:20 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Sanjoy Saibo (34/M) S/O Lt. Sunilal Saibo of Nimajote, P.O- Nimai, P.S- Matigara, Dist.- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of illicit Liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Sanjoy Saibo (34/M) S/O Lt. Sunilal Saibo of Nimajote, P.O- Nimai, P.S- Matigara, Dist.- Darjeeling and arrange for its investigation.
