Sir,

I, ASI Tapan Das of Matigara Police Station, Siliguri Police Commissionerate, do hereby lodge this written complaint, on producing one accused person namely Ajoy Sahani (27/M) S/O Lt. Ram Dulal Sahani of Biswascolony, P.O+P.S- Matigara, Dist.- Darjeeling under arrest along with following seized articles viz ; 09 (Nine) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml, Total 5.4 liters, value Rs.120X9=1080/-), and marked as 'exhibit -A' and 2] one bottle Himalayan Gold 60 UP Country Spirit taken out from exhibit -A as sample for examination and marked as "exhibit A-1" under seizure list (which is enclosed herewith) to the effect that on 18.12.2021 at 18.35 hrs received a secret source information that one person Ajoy Sahani (27/M) S/O Lt. Ram Dulal Sahani of Biswascolony, P.O+P.S- Matigara, Dist.- Darjeeling has stored huge quantity of Illicitly Country Spirit at his house without any valid license. Diarized the matter vide Matigara PS GDE No.902 Dt.- 18.12.2021 accordingly I informed the matter to O/C Matigara PS. and as per kind direction of O/C PS myself along with Const- 1008 Kanak Roy, CV- 387 Sukumar Barman left for Biswas Colony under Matigara P.S to verify the veracity of the source information. On reaching at the spot at 19.05 hrs it was found that huge quantity of illicit Country Spirit stored in the house of Ajoy Sahani who has also been selling the same to the common buyers. On being seen the police party the common customers fled away from the backside of the house. But we apprehend the above noted person namely Ajoy Sahani. Thereafter in presence of two available independent witnesses I search the house and seized illicit Country spirit Liquor after preparing proper seizure List duly signed by them and apprehend the person namely Ajoy Sahani. On being asked the said person failed to produce any document for selling and storing of illicit Country Spirit at the house. It's a violation under Bengal Excise Act. This seizure was made on 18.12.21 in between 20.55 hrs to 21:25 hrs. Label was also prepared against total seized articles. I then arrested the accused Person namely Ajoy Sahani (27/M) S/O Lt. Ram Dulal Sahani of Biswascolony, P.O+P.S- Matigara, Dist.- Darjeeling after preparing memo of arrest and intimating the ground of arrest. On being asked by police he stated that he running this illegal business of illicit Liquor at the said house and selling the same to the common customers since last few months without any license or permission of appropriate authority.

Hence I request you to start a case under proper section of Bengal Excise Act- 1909 against the arrested Ajoy Sahani (27/M) S/O Lt. Ram Dulal Sahani of Biswascolony, P.O+P.S- Matigara, Dist.- Darjeeling and arrange for its investigation.
