In producing herewith one (01) arrested accused person namely Md. Nasir @ Naran (48) S/O Lt. Anowar Ali of Biswas colony, P.O+P.S-Matigara, Dist. Darjeeling (not verified) along with the following articles under seizure as per seizure list:

- i) One packet containing 22.2 Kgs of "Ganja" wrapped with Yellow colour plastic and brown colour cello-tape being kept inside a red colour hand bag and marked as 'Exhibit-A';
- ii) One plastic pouch containing 50 grams of ganja extracted from exhibit 'A' for examination and marked as 'exhibit A-1'

I, SI Shekhar Adhikary S/O-Lt. Sonatan Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted person to the effect that on 19.12.2021 at about 13:15 hrs I received a specific source input that one person was standing at By-Lane near Jishu Ashram under PS Matigara with huge quantity of Ganja for delivering the same to their designed customers. The matter was diarized in Matigara PS GDE No. 945 Dt- 19.12.2021 and also informing the matter to the Officer-In- Charge, Matigara Police Station in written and being directed, I along with SI Rasbihari Saha, ASI Binod Jha, C/126 Satrughna Sen of S.O.G, SPC and ASI Nitai Mandal, Const-1035 Santosh Rabidas and Const- 1008 Kanak Roy of Matigara Police Station left for by-Lane near Jishu Ashram under PS- Matigara by Govt. vehicle to verify the veracity of the information. This refers Matigara PS GDE No. 946 Dt. 19.12.2021 and M.C C. NO 1379 Dt. 19/12/2021.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from Police Station I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to By-Lane near Jishu Ashram, I contacted two persons namely (i) Achinta Singh (22) S/O Akalu Singh of Pramod Nagar, P.O- New Rangia, P.S- Matigara, Dist- Darjeeling (ii) Jay Sarkar (22) S/O Nitai Sarkar of Paulpara, P.O+PS- Matigara, Dist. Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at By-Lane near Jishu Ashram at 14.15 hrs and being pointed by my reliable source detained one person standing there and carrying a red colour hand bag in his right hand under his exclusive and conscious possession.

Thereafter, we disclosed our identity and the information in hand stated him that he as well as the bag under his possession will be searched for the purpose. At this, he after disclosing his identity as noted above admitted that he has illegally possessed ganja in his possession for selling the same to his designed customers as per requirement. I then gave him option in writing whether he wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then he agreed to be searched in presence of any one of the above. I also offered the independent witnesses and the accused person to search our Police Party as per provisions but, they did not search the police party. Consequently, I informed the matter to O/C Matigara PS and as per his kind order, I informed to Shri Rajen Kumar Chhetri, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused person suspected to be possessed 'Ganja' and requested him to come at By-Lane near Jishu Ashram under Matigara PS to remain present and to supervise the search and seizure. At 15.05 hrs. Shri Rajen Kumar Chhetri, Assistant Commissioner of Police, Siliguri Police Commissionerate arrived at the spot as Special Executive Magistrate, SPC and in presence of two independent witnesses search has been conducted of the detained person following all formalities keeping decency and recovered the above noted articles from the exclusive and conscious possession of accused Md. Nasir @ Naran. On demand, in presence of Shri Rajen Kumar Chhetri, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC the detained person namely Md. Nasir @ Naran failed to produce any valid document in support of possessing of the Ganja.

Thereafter, I weighted the recovered packet with the weighing instrument which stand total of 22.2 (twenty two Kg and two hundred grams) Kgs and also extracted 50 grams ganja from packet for examination. Then, I seized the above noted articles at the spot under proper seizure list and also labeled and sealed the articles in presence of Shri Rajen Kumar Chhetri, Assistant Commissioner of Police, Siliguri Police Commissionerate acting as Special Executive Magistrate, SPC and independent witnesses and also obtained signature of the above noted witnesses and the Special Executive Magistrate, SPC and put my signature too and also acknowledged by the accused person. The whole process of seizure was made in between 15.15 hrs to 16.05 hrs.

Being further asked the apprehend person namely Md. Nasir @ Naran admitted in presence of Shri Rajen Kumar Chhetri, Assistant Commissioner of Police, Siliguri Police Commissionerate and other witnesses that he has procured the ganja clandestinely for the purpose of selling the same in high rate to his designed customer for personal gain by illegal means. He also disclosed that he has been dealing in such business of procuring and selling of ganja illegally for last few months.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused person namely Md. Nasir @ Naran is involved in procuring and selling of Ganja illegally contravening the norms of NDPS Act.


Then, I arrested the above noted accused person namely Md. Nasir @ Naran after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused person namely Md. Nasir @ Naran (48) S/O Lt. Anowar Ali of Biswas colony, P.O+P.S-Matigara, Dist. Darjeeling (not verified) and arrange for its investigation.


