(1) 15 (Fifteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 9 Liter & Amount Rs 1800/-).

I SI Swapan Ghosh of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Gopal Roy (35), S/O- Dhananjay Roy of Purba Majabari PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 18.12.2021 evening as per order of O/C. On reaching at Purba Majabari area as indicated by my source I held raid at the house Gopal Roy at Purba Majabari .But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his house. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles.
