Respected Sir,

With due respect I, Bikkay Sah, s/o Suresh Sah,
resident of Kholachand Papri, P.O. Baikunthapur, P.S. Bhaktinagar,
Dist - Jalpaiguri, West Bengal beg to state that today at around
06:00 pm one ① Uttam Ray, s/o Surendra Ray, ② Balram Ray,
③ Manmohan Ray, both 2 and 3 are sons of Surendra Ray
and their family members suddenly came to my place of
residence and started cursing and assaulting my mother i.e.
Mutul debi Sah, w/o Suresh Sah with fist and blows and
laid hands on her tearing her clothes with a serious
attempt to outrage her modesty. Then seeing this me and
my brother came to rescue my mother. Then the
aforesaid persons along with their family member came to
assault me and my brother with wooden battans and iron
rods. That after hearing the cries and shouts some neighbours
came to the spot. Seeing this the aforesaid persons ran
away with a threat that they shall come and kill me if
we went to lodge any complaint against them. Earlier today
at around 05:30 pm police officials had come to the spot
due to this ongoing spat between the aforesaid persons and
my mother. That after the police left the spot at around
06:00 pm the aforementioned incident took place.

The aforesaid persons are very desperate in nature and
they are threatening me that police officials are in their
pockets and they are not afraid of any police officials

That the aforesaid persons are still in the spot waiting for me and my family with 4-5 unsocial persons. That they are threatening that they shall drag me and my family in ^{fake} non-bailable cases.

They are capable of detaining law in their hands and can fatally harm my mother, me and my family.

So I therefore request before you to kindly look into the matter and start a specific case against the aforesaid person who all are resident of Kholachand Papri, P.O. Bailanthalpur, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal, under the provisions of law.

I shall be highly obliged for this act of kindness.
