private/personal loans from the local people and from banks and other financial company to meet the expenses for the said construction and on the inducement that my mother-in-law would help me to repay the loan amount out of her pensions and on her inducement, I availed loan from the local people and private financial service at high rate of interest.

- 6) That I somehow completed the construction of the first floor with the assistance of private loan amount availed from financial services and the local people but as the interest of the loan amount was/is high, I was unable to repay the interest to them and my mother-in-law also did not contribute from her end to repay the loans and for which the money lenders/financial company started to create pressure upon me to repay the loans but I was unable to pay them in due time.
- 7) That as the aforesaid loan amount was availed with the inducement of my mother-in-law, she hatched a conspiracy with my sister-in-laws, Smt. Kalpana Gurung, Wife of Puran Singh Gurung, Smt. Indu Mukhiya, Wife of Sri Nabin Mukhiya and her husband, Nabin Mukhiya to enter into the mutual agreement and on their dishonest inducement I entered into the agreement with them on 17-09-2019 and in terms of the said agreement, my mother-in-law shall sell the entire property i.e. the land and two storied building and out of the sell proceed shall repay the entire loan amount.
- 8) That on several occasions, I requested them to sell the property in terms of the said agreement, dated- 17-09-2019 but they did not perform their obligations but instead they continuously committed mental harassment and torture upon me and everyday abused me in slang and filthy languages and tried to assassinate my reputation and character and due to their unbearable mental torture, I tried to commit suicide but for the sake of my husband and my minor child could not commit the same.
- 9) That over the said incident, thereafter, I lodged a written complaint with the Pradhan Nagar P.S. on 05-02-2020 against them vide PDN P.S. G.D. Entry No.274/2020, dated- 05-02-2020 and thereafter filed a Misc. Case being No.15/2020 under the Protection of Women from Domestic Violence Act, 2005 against them which is still pending before the J.M. 4th Court, Siliguri due to the lodgement of said case against them, they are regularly putting pressure upon me to withdraw the case else to face dire consequences.

Respected Sir,

I, **SMT. JHARNA GHALEY**, Wife of Sri Sunil Ghaley, presently residing at Shib Mandir, P.O. & P.S. Matigara, Dist. Darjeeling, do hereby lodge a complaint against my, my mother-in-law, Smt. Krishna Kumari Gurung, Wife of Arjun Pradhan, my sister-in-laws, Smt. Kalpana Gurung, Wife of Puran Singh Gurung, Smt. Indu Mukhiya, Wife of Sri Nabin Mukhiya and her husband, Nabin Mukhiya, Son of Not Known, all are resident of Salbari, P.O. Methibari, P.S. Pradhan Nagar, Dist. Darjeeling to the effect that as follows:-

- 1) That my marriage was solemnized with one Sunil Ghaley, Son of N.K. Ghaley on 20-12-2004 and since my marriage, we had/have been cohabitating as husband and wife at my matrimonial house along with my mother-in-law and my sister-in-laws have been living nearby my matrimonial house.
- 2) That my mother-in-law is pension holder and I along with my husband had/have been living with my mother-in-law and I had/have looking after her with utmost care, kindness and attention.
- 3) That my husband is a Govt. employee who he is presently mentally ill and physically unfit and as such out of compulsion, I had/have to run, manage, decide and take every responsibility of the day to day household affairs.
- 4) That out of our said wed-lock, I gave birth to a male child on 22-11-2011.
- 5) That my matrimonial house having one storied building due to which there was no sufficient rooms for the guests and there was necessity and requirement of additional rooms in my matrimonial house, so, I consulted with my mother-in-law and she dishonestly induced me to construct first floor above one storied building by availing

- 10) That on 18-12-2021 at about 11:30, they created immense pressure and committed mental torture upon me at my rented house at Shib Mandir, Matigara to withdraw the said case else to face grievous hurt.

So, therefore, I humbly request you take necessary legal action against the abovenamed persons and booked them under the appropriate provision of law at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
