Respected Sir,

I, Surajit Paul, S/O Late Ajit Paul, R/o. Hakimpara, Atul Prasad Sarani, P.O & P.S Siliguri, District-Darjeeling, Pin- 734001, West Bengal, India, would like to state that today i. e. On 19-12-2021 at about 12.30 P.M. when I was at bagdogra airport one person namely Mr. Amal Roy, S/o Late Jagadis Chandra Roy R/o Near Central Bank of India, P.O & P.S Bagdogra Dist Darjeeling Pin 734014, West Bengal India suddenly called me and stated threatening me. When I asked him about the matter suddenly on of his friend namely Swapan Dey S/o Late Robi Dey R/o Near Chittaranjan School, P.O & P.S Bagdogra Dist Darjeeling Pin- 734014, West Bengal, came near me with sharp weapon and hit me with a tight blow in my nose. Due to his physical assault I sustained injury in my nose and blood was coming out in huge quantity from my nose. Mr. Amal also physically assaulted me and helped Swapan Dey in this act. On my hue and cry the nearby people came and solved me from their cruel hand. He was using slang language at me. He also threatened me with dire consequences. Both of them threatened ma that if I come to Bagdogra the will again beat me. Later I went to Bagdogra PHC, RKS for treatment & from there I went to North Bengal Medical College & Hospita.(The slips are attached with this FIR). I am fear that they might agan assault me. Finding no other option I came before you justice. Swapan Dey is driver and he drives one Innova bearing No. WB-78-3395.

It is requested before yo in folded hand take strict necessary action against Swapan Dey & Mr. Amal Roy.
