that my marriage was solemnized with Smt. Subrata Chatterjee
S/O Lt Parasanta Chatterjee on 3.12.1998 according to
Hindu Rites and Customs. Since after my marriage I
subjected to be tortured both mentally and physically by my
husband, named Subrata Chatterjee. As per demand of my husband
and in-laws has given cash coupons ~~₹~~ 2,00,000 ₹ and
others gold ornaments, On 6.12.2002 I gave birth to
a female child. Since then my husband started physical torture
upon me. Due to his Unbearable torture, I lodged a complain
at your P.S and over my complain started Siliguri Women P.S
no-92/21 dated 14.7.21 U/S 498A/506 IPC R/W
Section 3/4 D.P Act.

Later I came to know that my husband married a
woman Beavly Paramonik and started living together
at Siliguri. My husband and that lady restrained me
on the way to my home in different dates and they threatened
me in front of my house using slang languages even assaulted me stating
that if I do not withdraw my earlier case then they will
kill me evict me from my house. As they came into
my house and threatened me and my daughter a few days ago
Now, he and my daughter are feeling insecure about our lives.

In these circumstances I pray before your good self, necessary
legal actions may kindly be taken against my husband and that
lady.
