Sir,

In producing herewith arrested accused person named Shyamal Saha (43), s/o - Kartick Ch Saha, of - Ranidanga, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling along with copy of memo of arrest and seized articles viz (i) 16 (Sixteen) Sealed Old Monk premium rum Bottles each containing 180 MI Rs. 140/- each, (ii) 15 (Fifteen) Sealed Officers Choice Delux Whisky Bottles each containing 180 MI Rs. 130/- each, (iii) 18 (Eighteen) Sealed Imperial Blue Classic Grain whisky Bottles each containing 180 MI Rs. 160/- each, (iv) 18 (Eighteen) Sealed Mc Dowells No 1 Superior Whisky Bottles each containing 180 MI, Rs. 160/- each, totaling amount of Rs. 9950/- with proper police escort.

Received on 23/12/21 at 20:15 hrs with original copy of complaint forwarded to old Matigara PS. For starting a case under proper section of law and conducted by ASI Anupam Ray for investigation in accordance of your kind approval.

Today i.e on 23.12.2021 at 18.05 hrs, ASI Dulal Dey of NBMC OP along with C/131 Kanuram Sarkar, C/1082 Rahul Barman while conducting special raid against anti social elements, warrantees, ID liquor etc in vehicle no WB74/8035 at different area under NBMC OP in course of which I received an information from source that a person is selling and stored illicit Liquor in huge quantity in a clandestine way in patty shop at Laska Bridge under Matigara PS. During raid I found one Shyamal Saha (43), s/o - Kartick Ch Saha, of - Ranidanga, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling is possessing (i) 16 (Sixteen) Sealed Old Monk premium rum Bottles each containing 180 MI Rs. 140/- each, (ii) 15 (Fifteen) Sealed Officers Choice Delux Whisky Bottles each containing 180 MI Rs. 130/- each, (iii) 18 (Eighteen) Sealed Imperial Blue Classic Grain whisky Bottles each containing 180 MI Rs. 160/- each, (iv) 18 (Eighteen) Sealed Mc Dowells No 1 Superior Whisky Bottles each containing 180 MI, Rs. 160/- each, totaling amount of Rs. 9950/- hidden inside his shop and selling it to the customers in concealed manner. Accordingly I seized the above noted articles in presence of police witnesses, I demanded papers and license / cash memo of those seized articles but he failed to produce any documents in support of his possession of above noted illicit liquor. On interrogation, he disclosed his name as mentioned above and admitted that he procured the liquor illegally and had been selling the same illegally to the people. I accordingly, seized those illicit liquors U/S - 102 Cr.P.C in presence of witnesses after preparing proper seizure list duly signed by the witnesses as well as the accused and also labeled the same. Then, I arrested him u/s - 41 Cr.P.C with help of Police personnel. The search seizure, label and arrest were made from 19.10 to 19.25 hrs. Then we left the place with the arrested person and the seized articles.

Under the above circumstances I pray before your kind self that a specific case under proper section of law may kindly be initiated against the accused person named Shyamal Saha (43), s/o - Kartick Ch Saha, of - Ranidanga, PO - Ranidanga, PS - Bagdogra, Dist - Darjeeling and kindly arranged for its investigation.
