Salugara, P.S. Bhaktinagar, Dist - Jalpaiguri, West Bengal came to my afore said place of residence and started quarreling without any rims or reasons and they forcefully entered into my room and assaulted me with fist and blows. They even laid hands on me and tore the clothes that I was wearing with a serious intend to outrage my modesty. At the relevant time my husband had not returned from his work. While they were assaulting me, the aforesaid persons snatched a Gold chain from my neck.
