Subject: - F.I.R

Sir,

In producing herewith the seized 16 (Sixteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total-9.6 Liter & Amount Rs 1920/-) and lodged a written complaint against the accused person namely Smt Radhika Rai (55), W/O Ajay Limbu of Chota Fapri PS Bhaktinagar Dist Jalpaiguri.

I SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Smt Radhika Rai (55), W/O Ajay Limbu of Chota Fapri PS Bhaktinagar Dist Jalpaiguri to the effect that, on 23.12.2021 evening as per order of O/C Ashighar OP I along with ASI Amit Mallick C/877 Munna Ahmed ,L/C 497 Jharna Roy and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no.583 Dt 23.12.2021 in course of which I received information from my source that one Radhika Rai stored a huge numbers of bottles liquor inside her house at Chota Fapri and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Chota Fapri area to verify the veracity of information. On the way I called two local person namely (1) Dilip Ghosh (37) S/O Kali Charan Ghosh of Ghugumali PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Chota Fapri area as indicated by my source I held raid at the house of Radhika Rai at Chota Fapri. But the lady accused person managed to escape from the spot. I searched in the house of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside her house. I seized the above noted articles as alamath of the case, as none could be able to produce any documents for such illegal possession of such articles. During enquiry I came to know the name and address of lady accused person is noted above. The Search and seizure were made in between 16.15 hrs and 16.30 hrs on 23.12.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person Smt Radhika Rai (55), W/O Ajay Limbu of Chota Fapri PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
