Sir,

In producing herewith one arrested accused person namely Arit Majumdar (M-31) S/O Late Majumdar of Gokhel Road (Near Matri Bhandar), Arabindapally, Ward No-22, PS Siliguri, Darjeeling with seized articles (1) 20 (Twenty) bottles of 70 UP Country Spirit styled as Himalayan Fatatati of 3 each when packed, M.R.P Rs. 28/- each (2) 01 Nylon Bag which used for carrying the seized articles

I, SI Rana Brahma of Panitanki TOP under Siliguri PS herby lodge a written complaint again above noted accused person to the effect that today on 23.12.21 at 11:05 hrs during morning mobil duty I received secret source information that one person is carrying huge quantity of bottle of cc spirit through Bidhan road, near Auto stand and proceeded towards Rath Khola area. Accordingly I the matter to O.C Panitanki TOP and as per his direction I along with, ASI Surajit Mallick, C/984 Subl Das left for Bidhan road, near Auto stand to work out the information. On arrival at Bidhan road, near stand, at 11:15 hrs being pointed out by the source, found that one person is proceeding with huge qu of country spirit containing with a Nylon bag. Accordingly I intercepted the said persons with 1 articles in presence of witnesses. On interrogation the accused person disclosed his name and addr mentioned above. On demand he failed to produce any documents/license in support of the same stated that he will sale the same to the local public of Arabindapally and its adjacent area illegally view to earn huge money for his lively hood. Accordingly I seized 20 (Twenty) bottles of 70 UP C Spirit styled as Himalayan Fatatati of 300 ml each bottles when packed, MRP Rs. 28/-each and (2) 01 Nylon Bag which used for carrying the seized articles SI No- 1, under proper seizure list and label same in presence of witnesses and duly sign by them and also by the accused person. The seizure was between 11:25 hrs to 11:35 hrs. Then I arrested the above nfted accused person u/s 41 Cr.P.C explaining charge against him. Total value of seized articles is Rs.560/-.

Hence, under the above noted circumstances I am submitting this written complaint again above accused person namely Arit Majumdar S/O Late Amit Majumdar for starting a specific case proper section of Law and to arrange for its investigation.
