Sir,

In producing herewith arrested accused person namely Saraswati Roy (30 yrs) W/O Late Sagar Roy of C/O Gita Haldar, Gopal more, Deshbandhupara, Ward No. 30, PS- Siliguri, Dist- Darjeeling along with seized articles vize- i) 20 (Twenty) sealed Bottles of Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 20 =RS.2400/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list.

I, ASI Siben Sarkar of Siliguri PS, SPC do here by lodged a written complaint against above noted arrested accused person namely Saraswati Roy (30 yrs) W/O Late Sagar Roy of C/O Gita Haldar, Gopal more, Deshbandhupara, Ward No. 30, PS- Siliguri, Dist- Darjeeling to the effect that on 23.12.21 at 14.45 hrs acting on secret information, I received a source information that the above noted person was busy to sale ld liquor illegally in her rented house situated at Gopalmore , Nichpara, Ward No. 30 under Siliguri PS in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide Siliguri PS GDE no.1440 dated 23.12.21 and informed the fact to I/C Siliguri PS. As per direction of I/C Siliguri PS, I along with ASI Subir Sen, CV-283 Prosenjit Dey left for Gopalmore , Nichpara, Ward No. 30 under Siliguri PS under Siliguri to verify the veracity of the information vide Siliguri PS GDE no. 1441 dated 23.12.21. On reaching at 15.05 hrs there and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person and on interrogation, she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up Country Spirit to locality without any valid documents as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. On searching - i) 20 (Twenty) sealed Bottles of

Himalayan Gold 60 up country spirit each containing 600 ml. each labeled as Himalayan Endeavour PVT. Ltd. Siliguri, West Bengal @ Rs 120 each (Amounting of Rs 120/- x 20 =RS.2400/-) in which one sealed bottle has taken from mother packet box as sample which was kept concealed in her rented house situated at Gopalmore , Nichpara, Ward No. 30 under Siliguri. On being interrogation she could not produce any valid documents in respect of the said liquor. She also stated that she is doing this liquor business since long for wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 15.15 hrs to 16.15 hrs. As such I arrested her U/S-41 Cr.P.C after observing all sorts' of rules.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Saraswati Roy (30 yrs) W/O Late Sagar Roy of C/O Gita Haldar, Gopal more, Deshbandhupara, Ward No. 30, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigate.
