
With due respect, I am producing herewith one arrested accused person namely Ratan Mandal S/O-Lt. Haripada Mandal of Deshbandhu para, Ward no- 30, PS-Siliguri, Dist-Darjeeling, under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

21 (Twenty one) bottles of 60 Up Himalayan Gold Country Spirit containing 600 ml in each bottle.


I, SI Samik Paul presently attached with NJP PS under your kind control beg to state that today i.e. on 23.12.21 at 14.15 hrs I received a secret source information that one person namely Ratan Mandal S/O-Lt. Haripada Mandal of Deshbandhu para, Ward no- 30, PS-Siliguri, Dist-Darjeeling is selling ID liquor illegally at his hotel at station road under PS- NJP, Dist- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1581 dated 23.12.21 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy and VP/13 Jamirul Islam both of NJP PS, SPC left for NJP station to work out the information in hand. At about 14.35 hrs we arrived at shop of Ratan Mandal S/O-Lt. Haripada Mandal of Deshbandhu para, Ward no- 30, PS-Siliguri, Dist-Darjeeling and held raid at his hotel and managed to apprehended him. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between hrs 14.35 hrs to 14.55 hrs on 23.12.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ratan Mandal S/O-Lt. Haripada Mandal of Deshbandhu para, Ward no- 30, PS-Siliguri, Dist-Darjeeling and arrange for its investigation.
