Sir,

In producing herewith one accused person namely Ratan Sarkar (54yrs) S/O Lt. Adhir Sarkar of Baribhasa, Basbari, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. Ten (10) Bottles of Imperial Blue Classic Gain whiskey each bottle containing 180 ML.
2. Nine(09) Bottles of Himalayan Gold 60 up country sprit each bottle containing 600ML.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 23.12.2021 at 18:45hrs received a source information from Sahudangi more has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No-1231 dated 23.12.21. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) ASI. Sailendra Singh and (2) C/230 Subash Das proceed to Sahudangi more to work out the information. At 19:25 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahudangi More and recovered the above noted articles from the possession of above noted accused person namely Ratan Sarkar (54yrs) S/O Lt. Adhir Sarkar of Baribhasa, Basbari, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o. Lt. Narayan Sarkar of Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 19.35hrs to 19.55 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the accused person namely Ratan Sarkar (54yrs) S/O Lt. Adhir Sarkar of Baribhasa, Basbari, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri under proper section of law..
