I, ASI Khagen Barman of NJP PS, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted accused person to the effect that today i.e on 14.12.2021 at about 12.10 hrs I received a specific source information that 01 (One) person would be coming from Coochbehar side and proceed towards Kolkata with a suspected consignment of Ganja in a vehicle (Container) displaying number plate WB/25/J/3728. Accordingly, I informed the matter to SI Sameer Tamang, O/C NJP PS, SPC and I, diarized the fact in General Diary vide NJP PS GDE No 1619 Dated 14.12.2021 and as per order at 12.15 hrs I, along with ASI Sajal Das, C/1052 Paresh Rava, HG/794 Ranjit Roy, VP/08 Laxman Roy and VP/13 Jamirul Islam all of NJP PS left for Amaidighi, Opposite Kedar Hotel under PS- NJP, Dist.- Jalpaiguri to work out the information in hand vide NJP PS GDE No 1620 dated 24.12.2021 and Spl M.C.C. No. 2488/21 Dated 24.12.2021 by Govt. Vehicle taking necessary articles like white paper, Digital weighing machine, Arrest Memo, Seizure List, seal, gala wax, candles, match box etc. to verify the veracity of the information in hand.

Then, I arrested the above noted accused person namely Chandan Roy (24 yrs) S/O Haradhan Roy of Vill- Boro Garoljhora, PO- Salmara, PS- Sahebganj, Dist.- Cooch Behar after observing all guidelines of Apex court, as he violated the provisions of Narcotic Drugs by possessing said to be Ganja without any valid authority, document or license. On interrogation the accused person as noted above admitted that he procured the said to be Ganja from Dinjata side with a view to sale the same in Barasat for the purpose of making money illegally.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused person namely Chandan Roy (24 yrs) S/O Haradhan Roy of Vill- Boro Garoljhora, PO- Salmara, PS- Sahebganj, Dist.- Cooch Behar and arrange for its investigation.
