After my marriage, my husband brought me at his house 5B/5C, Dr. Jakir Hussain Road, T.V Tower, P.O., P.S. & Dist. Darjeeling, where we started to live and co-habited together as husband and wife and I have frequently visited at Hongkong and stayed most of the time at Hongkong witill 2013 and during my stay at Hongkong as per the direction of my Pradian Police Commissions husband, I started to send money to him from my own business. Since 2013, I have permanently started to reside at Darjeeling with my husband and during my stay, I found and noticed that my husband on a false plea have taken money with an intention to squeeze money for his own illegal purposes. My husband is a habitual drunker and also addicted with some contraband medicines and being a wife, I tried my level best to restrain him from the said addiction and inspite of my repeated request, he did not restrained himself from the said addiction and spend all my hard earn money for his lavish livelihood. My husband is also a person of suspicious and possessive character and every time, he created doubt upon my character if I talk with any of my friends boy's or girl's and every time, he created pressure upon me to give money to

him and if I refused to pay money to him as per his demand, he did not bother to assault me physically. I being a wife, has took all the responsibilities in and outside of my matrimonial house including my parents-in-law and being a son, he did nothing for his parents. In order to rectify my husband from his addiction, I have decided to purchase a property nearby to Salbari area under the jurisdiction of Pradhan Nagar Police Station and finally, I have purchased a landed property measuring 20 Kathas at Salbari area under Pradhan Nagar Police Station in the year of 2014 in the name of my husband Tashi Phuntsok Bhutia as I thought, after purchasing the property, he will change and rectify himself and I have paid the entire amount for purchasing the said property from my own fund and my husband did not pay any single amount and thereafter, I have constructed a building from my own fund and after completion of the said building, we have started to reside together in the said property. Even after purchasing the said property, my husband did not change himself from his earlier acts and attitude and he started to inflict torture upon me both physically and mentally and also started to blackmailing me by saying that he is the owner of the said property and if he desires, he may ousted me from the said property and taking advantage of the said situation, every time, he inflicted torture upon me. Thereafter, he started to blackmailing me that he belongs to a member of Tribal Community and he will not transfer the said property to and in favour of any other person except Schedule Tribe Community until and unless he desires though, it is very much within his knowledge that the said property was purchased by me out of my own fund. Thereafter, I have decided to purchase a four wheeler vehicle in my name and when this facts came to the knowledge of my husband, he bring a Pandit Jee namely Sunil Adhikary of Darjeeling at my residence at Salbari who told me that if I purchase the said vehicle in my name, I will have a bad luck and accident may occur at any point of time and instructed me to purchase the said vehicle in the name of my husband and believing the version of the said Pandit Jee and my husband, I have purchased a four wheeler vehicle (Hyundai Creta) being Reg. No. WB74-AU-1762 with the financial assistance of ICICI Bank Ltd. in the name of my husband and on regular basis, I have transferred the installment amount in the account of my husband for paying the same as EMI but even after transferring the said amount, my husband did not pay the same to the Bank and finally, I have settled the matter with the Bank and later, I realized that my husband in conspiracy with the said Pandit Jee told me some vulgar words in order to purchase the vehicle in his name. My husband inflicted torture upon me on regular basis just because, he does not want to return my own property and I used to bear all such type of inhuman torture of my husband with a hope that in near future he will definitely realize his own mistake and thereby rectify himself but all my hopes have gone in vain and on 24.01.2021, at about 11.00 P.M., my husband beaten me brutally with fist and blows and also assaulted my

by using a sharp cutting knife for which, I have received severe injury on my head and face and considering my severe injury, I went to Siliguri Government Hospital, where the attending Doctor treated me and thereafter, for a considerable period, I was in a bed ridden condition and treated myself as per the direction of the Doctor and still then also, I did not lodge any complaint against my husband considering his future career as well as due to fear that he again beaten me and kill me because, he wanted to grab my entire properties and I have the photographs of my said injuries. After the said incident, my husband makes apologies for his past conducts upon me and thereafter, he left and started to reside separately. Recently, my husband again started threatening me with dire consequences to pay a sum of Rs. 50,00,000/only to him otherwise, he will kill me and enjoy my entire property and to that effect, he has prepared some forged documents with an intention to grab my property for his wrongful and illegal gain and on 16.12.2021, he along with his associates, came near to my property at Salbari, Siliguri and asked me to put my signature on some blank documents and when I refused to put my signature as per his direction, firstly, he slapped me and also tried to attack me with a sharp cutting knife with an intention to murder me and later when I started hue and cry, he left the place and at the time of leaving the place, he along with his unknown associates have again threatened me with dire consequences and previously, my husband attacked and assaulted me with an intention to kill me but every occasion, I rescued myself somehow. It is also to be mentioned here that during the course of our martial relation, my husband has taken away all my valuables and jewelries without my consent and disposed off all the valuables and jewelries in the market for wrongful and illegal gain and when I asked about my jewelries and valuables, he flatly refused to return back the said articles.

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband for committing physical and mental torture, attempting to murder me as well as for preparing and manufacturing forged documents with an intention to grab my property, as per the provision of law and obliged thereby.
