With due respect and humble submission, in producing herewith one accused namely Goutam Chakraborty (35) S/O Lt Sudeb Chakraborty of 2/5 Baghajotin Colony, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) **16 (Sixteen) Plastic bottles of Himalayan Gold, Country Spirit, 60\* up each bottle containing 600 ML.**

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 18.12.2021 in course Special drive duty at PS area with force vide PDN PS GDE NO 881 dtd.18.12.21 , I received an information that one person namely Goutam Chakraborty is storing and selling liquor illegally in his hotel styles as " Madan Hotel " at Regulated market under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with , CV/646 Baban Das , CV/223 Swapan Chhetri rush to the spot and as pointed by the source we apprehended the above noted person and on search his hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21.05 hrs to 21:35hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Goutam Chakraborty(35) S/O Lt Sudeb Chakraborty of 2/5 Baghajotin Colony ,P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
