I ASI Ashit Singha of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 18.12.2021 in course Special drive duty at PS area with force vide PDN PS GDE NO 881 dtd.18.12.21 , I received an information that one person namely Shribas Biswas (26) S/O Sri Balai Biswas is storing and selling liquor illegally in his relative house at Baghajotin Colony near State Guest House under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with ,CV/242 Rakesh Mangar,CV/128 Ajay Kr Sahani rush to the spot and as pointed by the source we apprehended the above noted person and on search said house & recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 21.55 hrs to 22.25 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Shribas Biswas (26) S/O Sri Balai Biswas of Bانش Gola Road ,Nutunpara ,P.S& Dist -Murshidabad and arrange for its investigation.
