I Smt Lakpa Doma Yolmo, daughter of Topdan Yolmo, resident of Siliguri Lodge, near S.N.T, Himali Lodge, P.O & P.S Pradhan Nagar, Siliguri, would like to state the following:

That in the month of December, 2020, I met the above named Bittu Singh Nawbag at Siliguri, who is the son of Rudra Singh Nawbag resident of Upper Gumba Hatta, near C.E Hostel, Kalimpong.

That I am a single mother and for my livelihood I have my own restaurant at Pradhan Nagar, Siliguri. That after few months of his continuous approach I got in a relationship with Bittu Singh Nawbag.

That during the passage of time we stated sharing our feelings with each other and one fine day Bittu Singh Nawbag told me that he has a wife and a child but his wife passed away due to throat cancer. However, he never allowed me to meet his child.

That when I met Bittu Singh Nawbag, he fasely represented his name to be John Brotto Sada.

That after several days, I came to know that his wife is still alive but they did not stay together.

That thereafter we stated living together under the same roof(i.e., in a living relationship) at a rented apartment at Gurung Busty, Near Buddist Monastery, P.O & P.S Pradhan Nagar and my entire family know us a husband and wife.

That in the month of June, 2021, I got conceived and Bittu Singh Nawbag forced me to abort the unborn child.

That later on I came to know from my well wishers that Bittu Singh Nawbag lied me about his fake name John Brotto Sada and about his work as a RAW

Agent. Further, he told me that he have to go to other cities like Delhi for his work and told me he does not have money I, in good faith use to give him the money. Thus, till date I have given around 4,00,000/-(Four Lakh) money.

That Bittu Singh Nawbag even provided me his fake Aadhaar Card and Voter's Card which is self attested by Bittu Singh Nawbag.

That during the visit to my relatives at Darjeeling, he told the entire village that he is my husband.

That in the month of May, 2021 he went to work stating that he is going for an important mission of RAW, but later on I came to know that my gold bangles of 2 tola was missing from the locker and I never doubted him.

That after 15 days of his work he came back at my house in Siliguri and stayed with me for a week and again the sane incident occurred as he used to tell me that he is going for a work and use to disappear for a week and my gold ornaments also use to get missing. However, I did not doubt Bittu Singh Nawbag at all.

That in the month of August, 2021, I found a receipt wherein my said bangle was sold to a jewelry shop in Kalimpong. That thereafter, I asked Bittu Singh Nawbag about the jewelry, he admitted that he had stolen my gold bangles and had sold it in a jewllery shop and from then I begged him to bring me back my jewelry, till date he has been ignoring me.

That he also borrowed a sum of Rs, 50,000/-(Fifty Thousand) from my brother and has not returned the said amount till date. I further came to know from other sources that he had done fraud to other people as well.

That he use to have sexual intercourse with me in pertaining of marrying me in future and also fraudulently stole my jewelry.

Therefore, I pray before your good Office to kindly initiate the case and take proper action as I have been a victim of such fraud, theft, mischief, misrepresentation and rape. And that in future that person shall not repeat such offence to anyone.
