With due respect and humble submission, in producing herewith one accused namely Ramesh Roy (63) S/O Lt Rajendar Roy of Mallaguri, near Hunuman Mandir, P.S-Pradhannagar, Dist. Darjeeling, under arrest along with following articles under proper seizure ;

I ASI Debasish Das of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 23.12.2021 in course Special drive duty at PS area with force vide PDN PS GDE NO 1119 dtd.23.12.21, I received an information that one person namely Ramesh Roy is storing and selling liquor illegally in his tea stall at Mallaguri near Hunuman Mandir under Pradhannagar PS. Accordingly, I share the information to you and as per your kind instruction myself along with, CV/646 Baban Das, CV/ CV/242 Rakesh Mangar rush to the spot and as pointed by the source we apprehended the above noted person and on search said tea stall & recovered above noted articles, On der. and he failed to produce any valid document in respect of recovered articles. On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 19.15 hrs to 19.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Ramesh Roy (63) S/O Lt Rajendar Roy of Mallaguri, near Hunuman Mandir, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
