
I PSI Kamini Roy of Pradhan Nagar PS, SPC beg to lodge this written complain to the effect that today i.e on 24.12.2021 in course of patrolling van duty vide Pradha Nagar PS GDE No 1242 Dated 24.12.2021 received information that illegal mining of river sand and stone is going on by unknown miscreants at Mahananda Ghat under Pradhan Nagar PS area. Accordingly, I informed the matter to you and as per your kind order I along with force had been to the spot at around 15:15 hrs and found that some unknown miscreants were lifting sand and stone from Mahananda River. On seeing the police party all of them fled away leaving their tools, like Belcha which they were using to lift sand and stone from the river bed. I found four Belchas there and seized the same under proper seizure list the seizure was made between 15:25 hrs to 15:35 hrs

Under the above circumstances I pray that a specific case may kindly be started under proper section of law and arrangement for its investigation be done.
