I, Smt. Laxmi Shil W/O Sri Nimai Shil (Roy), permanently residing at Kawakhali, P.O. Shushrutranagar, P.S. Matigara, Dist- Darjeeling, beg to report you that my marriage was solemnized on 20th Baishakh, 1999 according to Hindu rights, customs and conventional rituals with Nimai Shil who reside in Near Gaishaal Mandir, Kawakhali, P.O. Shushrutranagar, P.S. Matigara, Dist- Darjeeling. After at the time of marriage I was residing with my husband and in-laws in Kholabaktari, Jhankar More, Siliguri, Dist- Darjeeling. That after few months later they started showing dissatisfaction regarding the dowry and sent me to my paternal house. Anyhow I return back and try to continue my marriage but on March, 2019 my husband engaged with some criminal acts and he was in jail for one year. After returning from jail he did not contact with me and suddenly on 23/12/2021 while I was going towards my work he suddenly caught me in the way of my work and threatened me with dire consequence that he will kill me, he was very dangerous in nature as prior he was indulged with criminal acts. I got very much afraid and somehow I escape from him and fled to the place of my work. He then at evening went to my house along with his sister named Rina Dey and again threatened me to kill me and used filthy language and he threatened me by saying that he will put petrol in his body in front of house. I am single parent of my two daughters and I reside with my old and ill parents. I am afraid that he can do anything anywhere.

I, therefore, request you to enter my report in the G.D.E. maintained by you and take necessary action against Nimai Shil and his family for save of my as well my family member's life.
