Sri Sanjeet Kumar Das S/o Sri Bhikari Das resident of Hemanta Basu Colony, SMC Ward No.- 4, P.O & P.S - Siliguri, District - Darjeeling would like to inform you that at about 11.00 P.M of 24 - 12 - 2021 my elder brother Ranjit Das, S/o Sri Bhikari Das, and his concubine namely Suchitra Sharma, D/o Late Sudhir Sharma, resident of Jyotinagar, P.O. & P.S.-Siliguri, District-Darjeeling have mercilessly assaulted my younger brother Sri Deepak Das S/o Bhikari Das with fist fitted with iron Knuckles (punch buckle). Blows, and iron rod, by felling him on ground on the issue of that at about 10.30 P.M of the same night my elder brother Ranjit Das was abusing my father and mother in Received on filthy languages and when my father Bhikari Das aged about 67 years made his protest 26/12/21 At against the said filthy language all of a sudden the said Suchitra Sharma came out and vide see PS forcefully dashed him causing he fell down and sustained sever knee injury and on his GDE HO-1622 BT-Started US, falling condition both the Ranjit Das and Suchitra Shara have started assaulting him by foot and when my younger brother Deepak Das tried to save Bhikari Das,, though the said Ranjit PS CARRE NO Dr. 26/1/11 Das and Suchitra Sharama left Bhikari Das but have started assaulting Deepak Das with WS 341/323/intention to kill him and due such attempt of killing Deepak Das by fist fitted with iron Knuckles (punch buckle). Blows, and iron rod, he not only sustained internal sever injuries 324/509/504/ 34 9PC. but his four teeth of front side became displaced and several cut injuries on his face and lips

and blood starting oozing from his mouth and other injuries and he became senseless. After bearing hue and cry when the neighbours started gathering, the said Ranjit Das and Suchitra Sharma fled away from the spot with threatening that my entire family will face serious consequences. After the said incident, I with the help of local people brought my father Bhikari Das and younger brother Deepak Das to Siliguri Sadar Hospital. After dressing of the injury of my father he was discharged but due to sever injuries my younger brother Deepak Das is admitted to Hospital and he is fighting for his life and death due to his internal injuries and teeth injuries.

So requesting you to investigate the matter and take necessary legal action against the said Ranjit Das and Suchitra Sharma for the interest of justice. For the treatment of my brother And father I was busy causing I could not lodge my FIR soon after the incident.
