Sub : Complaint against my in - laws.

Dear Madam / Sir,

I Suchitra Das W/o Sri Ranjit Das resident of Hemanta Basu Colony, Ward No. 4 of S.M.C, P.O. & P.S. - Siliguri, Dist - Darjeeling, Pin - 734005 do hereby lodge a written complaint against 1) Sri Bhikari Das, S/o - Lt. Sundar Das 2) Smt. Sankaro Devi Das W/o - Sri Bhikari Das 3) Sri Sanjit Das, S/o - Sri Bhikari Das 4) Smt. Nilam Das, W/o - Sri Sanjit Das and 5) Sri Dipak Das, S/o - Bhikari Das all are resident of above noted address, to the effect that on 24/12/2021 at about 10.30 pm, when I was at my matrimonial house along with my husband and daughter namely Harsha Das (14 Years), suddenly all of the above noted persons started abusing me in filthy languages and quarrelling with me and when my daughter and husband protested that time they caught my daughter with her hair and pushed her on floor and physically assaulted me and my husband. When my husband tried to rescue me they physically assaulted my husband with fist n blows. My husband got injury in his right hand.

That time my brother in law namely Sri Sanjit Das and Dipak das used criminal force upon me, torn my clothes and tried to outrage my modesty. I received severe injury on my lower abdomen and head and started bleeding from my vagina.

Somehow my husband managed to rescue me and I along with my husband went to Siliguri District Hospital and got treated there.

My in-laws are very much desperate and dangerous in nature and they are continuously harassing me and assaulting me physically and trying to kill me.

It is pertinent to mention here that on earlier occasion also I have lodges complaint against my in-laws dates 31/03/2021 and on 17/08/2021 and on strength of the said complaint Siliguri Women Police Station started specific case against the above noted persons being Siliguri women P.S. Case No - 43 / 2021 , Under Section 498 A / 506 / 109 of I.P.C and Siliguri Women P.S. Case No - 110/2021 - Under Section 498A / 506 of IPC in which they are on bail and the cases are pending before the Ld. A.C.J.M at Siliguri.

I am in panic as our lives in danger. So I request your good office to take necessary legal steps against the above noted accused persons and oblige me.
