That I "Anjani Kamat" W/o Binod Biswas Hindu by religion resident of Mallaguri, Green Park, Pokaijote, Ward NO. P.O. & P.S. Pradhan Nagar, Dist- Darjeeling begs to inform you that-

1. That I was married to "Binod Biswas" S/o Late Yogendra Biswas Hindu by religion resident of Sonbarsa, near Raj Mahal, P.O. Sonbarsa, P.S. & Dist- Saharsa, Bihar, on 11/07/2013 and we have a son aged about 7 years in our wed-lock.
2. That my stay in my matrimonial house was not fruitful. During my stay my in-laws namely Sabita Devi (mother-in-law), Binita Devi (sister-in-law) and Manish Biswas (brother-in-law) mentally and physically tortured me. My husband never supported me and always stood beside them.
3. That my in-laws proposed my father for my marriage with their elder son (Binod Biswas). They asserted that my husband is running a Coaching Centre and gives tuition to student and affirmed us that he is well-established financially and socially.
4. That after my marriage I discovered that my husband doesn't have any source of income. And after few days of my marriage my above mentioned in-laws started torturing me mentally as well as physically.

That today i.e. on 27.12.21 at about 10.am my husband and his mother namely Sabita Devi, his sister namely Binita Devi came to our home and told me to sign on divorce papers when I refused to do the sign on the divorce papers brought by them, they started abusing me in filthy and offensive languages when I restrained them then all of them caught hold my hair log and started assaulted me, they almost assault me for 10/15 minutes hearing this my mother came to save me at that time they also assault my mother, finding no other alternative we raised hue and cry seeing this they started fled away from the spot but before that they threatened us that any opportunate moment they would kidnap my son and murder him.

I request you Sir to take stringent action on my husband and his mother and sister and other in-laws as I am in constant state of fear with my son and parent's.
