Respected Sir,

With due respect, I, SMT. BHARATI PAUL, D/O Sri Chinmoy Paul, W/O Sri Abhijit Paul, presently residing at Nazrul Sarani, Ashram Para, P.O. & P.S. Siliguri, Dist. Darjeeling, beg to state that on 08.03.2019 my marriage was solemnized with Abhijit Paul, S/o Manik Chandra Paul resident of 132/5, Binapani Bhawan, Rash Behari Bye lane, Rabindra Nagar, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin-734006, as per Hindu Rites & Customs at my parent's house situated at Nazrul Sarani, Ashram para, P.O. & P.S. Siliguri, Dist. Darjeeling. At the time of marriage, my parents and other relatives and well wisher have gifted me golden neckles, earrings, bangles all together 15 bhoris of gold and I also received from my parents and other relatives other wooden furniture's, cloths, etc amounting to Rs. 3,00,000/- and after marriage I have taken all the above mention gold and furniture's to my husband's house and after reaching at my husband's house, my mother-in-law, father in law and my husband has taken all the above mention gold from me and kept those gold and valuable utensils, furniture's clothes in their own custody.

That after the laps of 15 days of my marriage, my husband, my mother-in-law namely Smt. Bina Paul and my father-in-law namely Sri Manik Chandra Paul, created pressure upon me for bringing an amount of Rs.5,00,000/- (Five lac) only from my parents and when I refused to bring amount of Rs. 5,00,000/- (Five lac) only from my parents, my husband and other in laws member created tortured upon me both physically and mentally. My husband used to assault me by fist and blows for demand of Rs. 5,00,000/- only. I was not provided sufficient food and I was not allowed to talk with the neighbors.
