Matigara , Dist – Darjeeling , want to lodge this written complaint to the following facts that yesterday night (29/12/2021) at about 2 a.m we have closed our restaurant come bar according to the direction of your good authority. There after sometime when we were managing our cash and everything then 5-6 people came infront of our restaurant and demanded to get enter in our premises. Then I accordingly inform them that it is closed and we are unable to serve them further. They told me they are the staff of Dawat in Bengal of 2nd floor and they wrong fully entered in our restaurant and started to threatening me and my staff that if we did not serve them then we have to surfer a lot but I refused them to serve further politely. Those persons became very furious and started to used filthy languages to us. When I tried to privent them, they assaulted me dangerously and force fully took me to the second floor at Dawat in Bengal. They have abducted me and forced me to be their against my will, they assaulted me again and all staffs of said Dawat in Bengal went to our restaurant and broke the cash counter and forcefully took away the whole cash from my cash counter which amounting to 60,000/- (sixty thousand rupees) and destroyed and broke all the valuable properties of our restaurant. at the time they have intentionally assaulted some of our female staffs also.

Later on our director sri Keerat Singh came to the spot and tried to rescue me from the s Dawat in Bengal. Somehow he rescued me and when we were at our restaurant tried to inform the police then again those people (15-20 peoples) came to our restaurant with dangerous weapons like sharp cutting, instruments, knife, lathi, iron rod and attacked over Mr. Keerat Singh with a intention to kill him and dangerously hurt him over his head by iron rod and when he fell down then one of our staff Subhankar Biswas and myself tried to rescue him. At the time they hurt Subhankar Biswas with iron rod and knife, and he got severe injuries over his head having a deep cut injuries over there. Then being prevented they left the place.

Now, the physical condition of Subhankar Biswas is very dangerous and he got admitted in one nursing home for his treatment. The whole incident has been recorded in our c.c t.v camera.

I am therefore praying please take proper legal action against the owner, manager, staffs of Dawat In Bengal and other culprits and arrest them immediately for the ends of justice.
