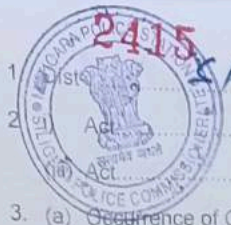


Sir,

In producing herewith one accused person namely Sanju Barman (22), S/O- Lt. Sashi Barman of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling along with seized articles viz., 1] 12 (twelve) bottles of Kingfisher Strong Premium Beer each bottle containing 650ml, total 7.8ml, value total Rs.12X130=Rs.1560/- and marked as 'exhibit -A' and 2] one bottle Kingfisher Strong premium Beer taken out from exhibit -A as sample for examination and marked as "exhibit A-1" I,PSI Shekhar Adhikary presently posted at Matigara Police Station, Siliguri Police Commissionerate would like to lodged this written complaint against the above noted person that today (30.12.2021) at 19.15hrs onwards while performing Special raid duty, myself along with ASI Tapan Das, C/1035 Santosh Robidas and CV-387Sukumar Barman had been to Matigara Bazar area and found that selling and storing of liquor was going on at the shop of the aforesaid person. Then I cordoned the shop with my accompanied force and detained the person who on being asked disclosed his identity as noted above and stated that he is the owner of the shop. On being search of his shop in presence of available witnesses the above noted seized articles are found inside his shop. On being asked he failed to produce any valid license/papers for selling and storing of such articles. Then I seized the above mentioned articles under proper seizure list in presence of witnesses whose signature have also been taken in the seizure list and subsequently arrested the above mentioned person. While on the time of cordoning off the shop, the persons who were having liquor at the shop manage to flee from the spot. On further interrogation of the arrested person it could be learnt that he is involved in selling and possessing the liquor without any valid license for his illegal gain. The seizure has been made in between 20.05 hrs. to 20.35 hrs.

Therefore, I pray before your good self that a specific case against the above noted accused persons namely Sanju Barman (22), S/O- Lt. Sashi Barman of Matigara Bazar, PO+PS- Matigara, Dist- Darjeeling may kindly be initiated under proper section of law and may cause for its investigation.


