Respected Sir,

I, **SRI VINEET BANSAL** S/o Sri Binod Kumar Bansal, resident of Pusp Niwas, Viswakarma Mandir Road, Khalpara, Siliguri-734005, P.O. & P.S. Siliguri in the District of Darjeeling would like to lodge a complaint stating the following facts:

1. That my house is situated near Paramount Hospital and since last few months the staffs, employee and other members of the Hospital used to park their vehicle on the roads which often block the passage and causes huge inconvenience to the local resident.
2. That today i.e, on 28.12.2021 at about 1.30 p.m. as I was crossing the Paramount Hospital, I had an encounter with one of the employee of the Paramount Hospital wherein I requested him to not to park the vehicles on the road, blocking the roads. Thereafter Pintu Rustogi, S/o Hari Rustogi along with three of his bouncers came out of the Hospital and started shouting at me to which I tried to explain the problem faced by the people of the area.
3. That I had not even completed the sentence when the said person hit me with a blow. Thereafter the bouncers of the said Pintu Rustogi punched me on my forehead and pushed me on the ground.
4. That they also kicked me on my abdominal with intent to harm me. The bouncer were also in possession of an iron rod, hand knife and they openly declare that they will leave no stone unturn to kill me. He even stated that his bouncers have been instructed to end my life. The said Pintu Rustogi then caught hold of my neck and tried to suffocate me and choke me to death.
5. That time and again the said Pintu Rustogi and Naresh Singla (owner of the hospital) had threatened me to not intervene in the parking issue as he is an influential man and has great connection with the politician and donot fear to take law in his hand.
6. That on hearing the hue and cry, the residents of the area gathered and rescued me from the hands of the bouncers of the said person and took me to Siliguri Sadar Hospital. The bouncer had hit me so hard that I was not in the position to stand on my own feet. Had the resident not rescued from the hands of Pintui rustogi who had the intention to kill me by pressing my neck, I would have succumbed to death on the spot.

7. That time and again the aforesaid person used to threaten me and the other residents of the area to stay away from Hospital and follow his direction if they wanted to leave in his area
8. That Around 4-5 days back I was called by Naresh Singla and Pintu Rustogi where they had threatened me to stay away from the matter or else I should be ready to face the consequences.
9. That the whole incident was preplanned and was done with an intention to kill me so that he could set an example for the other residents.
10. That the said person has been carrying on the said act under the instigation of Naresh Singla, who is the owner/ director of the said hospital.
11. That the said person is not only a threat to me but also to the entire residents of the area. On several occasion he has not only threaten me but also the other resident of the area. I fear that the said person can harm me and my family and a stringent action is to be taken against such dangerous person.
