1. That I had lodged an F.I.R. against Rintu Choudhary at Bhaktingar P.S. for cheating / Usurping Rs. 38,000/- from me and a specific case Vid. Bhaktinagar P.S. Case no- 120/2021 dt. 04/02/2021, u/s 406/420/379/506/34 of IPC was started against said Rintu Choudhary and after the initiation of the aforesaid case the said Rintu Choudhary came to me and requested me to settle and compromise the matter on condition that he will pay Rs. 38,000/- in installment every month and on his such repeated request.
