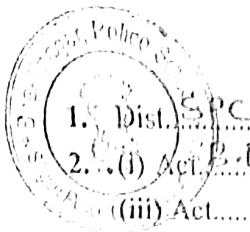

Sir,

In producing here with the one accused person namely Ali Husain Md @ Sohail (25) s/o Samir Md of Kamalanagar, PO. Salugara, , Ward no 42, PS Bhaktinagar, Dist- Jalpaiguri along with following seized articles as per proper seizure list:

1. Eleven (11) bottles of Galaxy Boss 60 UP Country Spirit each bottle containing 300ml.
2. Seven (07) bottles of McDowell's No. 1 Celebration Matured XXX RUM each bottle containing 180 ml.

I, PSI Sailesh Subba of Bhaktinagar PS under Siliguri Police Commissionerate lodged this written complaint against the above noted accused person to the effect that on 30/12/2021 during Mobile van duty at around 15.15 hrs received a secret source information that the above noted accused person has stored huge amount of Liquor illegally in his house for selling the same to the local customers. Accordingly the information share before you and as per your kind direction myself along with Constable C/762 Mujibur Rahaman , CVF- 614 Sumit Kr Roy, CVF, 619 Dharmendra Roy headed towards Salugara to verify the veracity of the information. At about 15.45 hrs we reached at Salugara, Kamalanagar and entered at the aforesaid House and apprehend the above noted accused person who disclosed his identity as noted above and searched his house and recovered 1] Eleven (11) bottles of Galaxy Boss 60 UP Country Spirit each bottle containing 300ml. 2] Seven (07) bottles of McDowell's No. 1 Celebration Matured XXX RUM each bottle containing 180 ml. On enquiry the apprehended person admitted his guilt and stated that he has been storing and selling the above recovered liquor to the local customer since long without any valid licence or Documents for his wrongful gain. Accordingly, I prepared seizure list of the above noted articles in presence of witnesses duly sign by the accused as well as witnesses. The seizure made between 16.10 hrs to 16.35 hrs. As he has violated the rules and norms of Bengal Excise Act hence I arrested the apprehended accused person u/s 41 Cr.P.C appraising him the ground of arrest.

I, therefore pray before your kind honour that a specific case may be started against the accused person namely Ali Husain Md @ Sohail s/o Samir Md of Kamalanagar, PO. Salugara, , Ward no 42, PS Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for its investigation.
