Sir,

In producing herewith one accused person namely Samit Das (41), S/O-Late Bholanath Das of Madhya Shantinagar PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure: Siliguri Dist. of Madhya

- (1) 16 (Sixteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.100/- (Total- 9.6 Liter & Amount Rs 1600/-).

SI Pradip Kr Singha of Ashighar OP lodged a written complaint against the accused person namely Samit Das (41), S/O-Late Bholanath Das of Madhya Shantinagar PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 03.12.2021 night as per order of O/C Ashighar OP I along with ASI Ujjal Mandal C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elements, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 78 Dt 03.12.2021 in course of which I received information from my source that one Samit Das stored a huge numbers of bottles of liquor inside his Tea stall at Jaleshwari bazaar and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Jaleshwari bazaar area to verify the veracity of information. On the way I called two local person namely (1) Dipankar Saha (38) S/O Naresh Saha of Niranjnagar Ghogomali PS Bhaktinager Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranjnagar W/no.36 PS Bhaktinager Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching Jaleshwari bazaar area as indicated by my source I held raid at the Tea stall of Samit Das at Jaleshwari bazaar But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the Tea stall of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his Tea stall. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 23.05 hrs and 23.25 hrs on 03.12.2021.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Samit Das (41), S/O-Late Bholanath Das of Madhya Shantinagar PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
