Respected Sir,

With due respect, I SMT. GITA SHARMA, Wife of Sri. Anirban Chakraborty, Daughter of Late Yogendra Sharma, presently residing at Sarada Sky Rise Apartment, 6th Floor, Dagapur (Opp. Pintail Village), P.O. & P.S. Pradhannagar, Dist. Darjeeling, West Bengal-734003 beg to state that I have entered into marriage with SRI. ANIRBAN CHAKRABORTY(M-98320 07086), Son of Late Ashit Chakraborty, resident of Anandamoyee Colony, P.O. Champasari, P.S. Pradhannagar, District-Darjeeling, W.B.-734003 and our marriage was solemnized on 06/05/2016.

Before marriage with Anirban Chakraborty, I was a general order supplier and I used to work in different Government projects in Sikkim like NHPC, Hindustan Construction Co. etc. and used to earn more than Rs.3,00,000/- per month and at the time of marriage, I had considerable amount of savings, Assets, Investments in my own name.

Since the date of marriage, my husband and in laws have tortured me by both physically and mentally and finally they have driven me out from their house and I was compelled to file a written complaint to the Pradhannagar Police Station, Dist. Darjeeling against my husband and in laws being Siliguri (W) PS Case No. 99/2021.

That during the conjugal life, I had faith upon said Anirban Chakraborty but from the very beginning with dishonest intention, he has misappropriated all of my assets, savings and he has also induced me to purchase some properties in his name for the purpose to cheat me.

On 05/03/2020, I had purchased a covered parking space measuring 154 Sq.ft., situated at Mouza Mandlaguri, Near Champasari More, Bharat Complex, under Plot No. 535, Khatian No. 61/4, P.S. Pradhannagar, Dist. Darjeeling by virtue of registered deed of conveyance being no. I-1594 of 2020 from my own fund, but my husband most illegally and forcibly occupying my said covered parking space by converting it to his Lawyer's Chamber.

Recently on 27.12.2021, I have received a notice issued by Ld. Lawyer of my husband and I have been informed that my husband has filed a civil suit against me being T.S. No. 114/2021, where my husband has placed a deed of agreement for sale dated 12/11/2020 where the Vendor's name is specifically mentioned as "GITA SHARMA" in respect of above mentioned parking space.

I have not sold my above property to my husband and have also not executed any such agreement for sale, but for the purpose to grab my property, my husband has forged my signature and introducing as Gita Sharma, and he has thereby made the said deed of agreement dated 12/11/2020 in collusion with the staffs of my husband whose names are mentioned as witnesses in the said agreement.

That by playing fraud, misrepresentation, forging my signature and swearing false affidavit my husband has been trying to grab my own property.

Therefore, I request you to kindly look into the matter and to take necessary legal action against my husband SRI. ANIRBAN CHAKRABORTY(M-98320 07086), Son of Late Ashit Chakraborty, resident of Anandamoyee Colony, P.O. Champasari, P.S. Pradhannagar, District-Darjeeling, W.B.-734003. And for this kindness, I shall much oblige to you.
