Sir, I Sri Sanjit Chakraborty (46 yrs) S/O Narayan Chakraborty of Pancharan Road, Fokdaibari, Dab gram - II. PO:- Ghughumari Dist:- Jalpaiguri like to draw your kind attention that on 15/9/20 (15/9/21) one Kunal Adhikary called me over my cell no- 9074547992 from his Mobile no- 8017072214 offering me a loan amount of Rs- 2 Lakhs from Bajaj Finance. I agreed from his proposal and send my Aadhar Card, Pan Card, Voter ID. and photo etc as their requirement to his whatsapp numbers and also told me one life insurance to be initiated after paying Rs- 17000/- in Sirmam Life for security deposit, according I paid Rs- 17000/- through Paytm in favour of A/c no- 80021035002166 HDFC bank. After a long gap my loan was not sanctioned, contact with Kunal Adhikary he gave me another contact number, i.e. 9073150517 which is now activate. He again demanded Rs- 17750/- and one Raja Sree Roychowdhury also demanded Rs- 17750/- from her mob no- 9073150514 strengthen the insurance policy. However I paid Rs- 17750/- in the A/c no- 7376020008850, IFSC Code- UBIN0573761 of Union Bank through Paytm on 12-11-21 but till today loan was not sanctioned. Then I rushed in the office of Bajaj Finance, seroke road Siliguri and they make me clear that I have been cheated by the fraudsters. Today I visited the Sirmam life insurance office Bindwan road and got the policy of life insurance of Rs- 17000/- but rest 17750/- have been cheated by the fraudsters.
