Sir,

In producing herewith two (02) arrested accused person namely 1. Mojaffar Ali (29) s/o Mustafa Ali of Narayanjote, Gatra PS Rajganj Dist. Jalpaiguri and 2. Tofajul Seikh (30) s/o Matlu Seikh of Mondai, Chakbahadurpur PS Baisnabnagar Dist. Malda alongwith following seized articles viz,

- i. One zipper transparent thin plastic packet in contents 250 grms (two hundred fifty) said to be brown sugar (Heroin) which recovered from the possession of Mojaffar Ali (29) s/o Mustafa Ali of Narayanjote, Gatra PS Rajganj Dist. Jalpaiguri, Market as Exhibit -A.
- ii. 10 (Ten) grams of said to be brown sugar (Heroin) which drawn from exhibit-A as sample for examination packed, sealed, labeled and marked as exhibit-A-1.
- iii. One zipper transparent thin plastic packet in contents 250 grms (two hundred fifty) said to be brown sugar (Heroin) which recovered from the possession of Tofajul Seikh s/o Matlu Seikh of Mondai, Chakbahadurpur PS Baisnabnagar Dist. Malda, Market as Exhibit -B.
- iv. 10 (Ten) grams of said to be brown sugar (Heroin) which drawn from exhibit-B as sample for examination packed, sealed, labeled and marked as exhibit-B1.
- v. One mobile handset model Samsung DUOS, Black colour IMEI No. 353846950716729/01 & IMEI No. 358846270716727/01 from Tofajul Seikh.
- vi. One Android mobile handset model OPPO Sim connection No. 9832525008, IMEI No. 864693046039514 & 864693046039506 from Mojaffar Ali.
- vii. One Motorcycle PULSER 150 having registration No. WB-74-AS- 2069, Black & Red colour with key.

I, SI Debabrata Khan of Bagdogra Ps, Siliguri Police Commissionerate do here by lodged this complaint against 1. Mojaffar Ali (29) s/o Mustafa Ali of Narayanjote, Gatra PS Rajganj Dist. Jalpaiguri and 2. Tofajul Seikh (30) s/o Matlu Seikh of Mondai, Chakbahadurpur PS Baisnabnagar Dist. Malda to the effect that on 02.01.22 at 12-15 hrs received a secret source information that two persons with Pulsar Motorcyle are standing near Gossainpur Uttara Gate No. 2 near Laska bridge who have huge quantity of brown sugar for clandestinely disposal of the same illegally. The matter was diarized vide Bagdogra Ps GDE No-57 dt-02.01.22. Accordingly, I informed the matter to O.C, Bagdogra PS as per his instruction at 12-25 hrs myself along with ASI Dharendra Nath Mandal, ASI Madan Rishi, C/410 Montosh Singh, VP-01 Ansalam Kujur, CV/375 Jogesh Barman, CV-386 Kishor Ranjan Howlader left for the spot to verify the veracity of the information vide corresponding Bagdogra Ps G.D.E. No. 58 dtd 02.01.22 and Bagdogra PS M.C.C No- 21/22 Dt.02.01.22.

At the time of departure from Police Station I bring spring weighing clock, small balance with stone, envelope, paper, sealing wax, gum, seal etc. On way to spot at Gossainpur near Laska Bridge meanwhile I called two independent witnesses namely [1] Tapash Barman (29) s/o Lt. Lalit Barman of Gossainpur near Hanuman Mandir Ps Bagdogra Dist. Darjeeling and 2. Barun Roy (21) s/o Lt. Ramsogarath Roy of Singhijhora Tea Estate Bara Line Ps Bagdogra Dist. Darjeeling informed them about the information in hand and requested them to accompany us to witness the search and seizure if necessary. At about 12-55 hrs on arrival there by govt. vehicle as identified by the source we surrounded the place and found two persons sitting on a Motorcycle at Gosainpur near Laska bridge, in front of Uttara Gate No. 2, seeing the police, they started the motorcycle and tried to flee away. On hot chase, we apprehended the two persons with said Motorcycle. On being asked they disclosed their identity as noted above. After disclosing our identity I

asked them whether they wanted to be searched in presence of Executive Magistrate or any Gazetted Officer and they agreed to search by any one. I served her option notice accordance with provisions of law in this regard in writing and they also gave her approval of being searched by any one in writing in the notice serve to them. Accordingly I informed the matter to O.C. Bagdogra Ps and he informed me over mobile phone to send one requisition to Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC as Special Executive Magistrate . Accordingly I informed to Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC in written by sending messenger with request him to came immediately to the spot. At about 14-25 hrs Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC and O.C. Bagdogra PS arrived at the spot. I disclosed the identity of Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC to the accused persons as Special Executive Magistrate and also witnesses. I also offered the independent witnesses and the accused persons to search our Police Party as per provision of law. But they refused to search the police party. Under supervision of Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC and in presence of independent witnesses I conducted searched and recovered two zipper transparent thin plastic packets in contents said to be brown sugar (Heroin) from the possession of the above noted apprehended persons which was concealed in the right pocket on the front side of their Pant. On demand in presence of the Spl. Executive Magistrate Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC they failed to produce any valid document in support of possessing of the same.

I accordingly weighed the recovered said to brown sugar by the weighing instrument total 500 grams in two plastic packets. Then I seized the above noted articles as proper seizure list and label duly signed by the above noted witnesses and the Spl. Executive Magistrate Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC and acknowledged by the accused persons. On further asked the apprehend persons confessed in presence of Spl. Executive Magistrate Sri Moksedur Rahaman ,ACP, ICP Fulbari, SPC and other witnesses that they procured the said brown sugar (Heroin) clandestinely from Kaliachak, Malda for the purpose of selling in order to earn huge money illegally and they are also addicted to brown sugar. Then I arrested the above noted two accused persons u/s- 41 Cr.P.C after observing all formalities of arrest as well as after disclosing the cause of arrest and issued Memo of Arrest .The copy of seizure list and Memo of Arrest has been supplied to above noted accused persons under proper receipt as the accused persons violated the terms and condition of NDPS Act. The seizure and arrest was made between 15-05 hrs to 16-25 hrs


Under the above circumstances, I pray to you that a specific case under proper section of Law may kindly be started against the accused persons namely 1. Mojaffar Ali (29) s/o Mustafa Ali of Narayanjote, Gatra PS Rajganj Dist. Jalpaiguri and 2. Tofajul Sheikh (30) s/o Matlu Sheikh of Mondai , Chakbahadurpur PS Baisnabnagar Dist. Malda and arrange for its investigation.
