With due respect, I am producing herewith one arrested accused person namely Alok Sarkar (62 yrs) S/O late Manoranjan Sarkar of Vill- Jhakuapara, PO- Pandapara Kalibari, PS- Kotwali, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

1. 18 (Eighteen) bottles of 60 Up Himalayan Gold Country Spirit containing 600 Ml in each bottle.
2. 06 (Six) bottles Kingfisher Strong Premium Beer containing 650 Ml in each bottle.
3. 03 (Three) bottles Budweiser Larger Beer containing 650 Ml in each bottle.
4. 05 (Five) bottles of Mc Dowels No 01 Celebration Matured XXX RUM containing 180 Ml in each bottle.
5. 08 (Eight) bottles of Imperial Blue Classic Grain Whisky Containing 180 Ml in each bottle.
6. 11 (Eleven) bottles of Old Monk XXX RUM containing 180 Ml in each bottle.
7. 11 numbers of paper made pouch of Officers Choice containing 180 Ml in each pouch.

I, SI Goutam Mallik presently attached with NJP PS under your kind control beg to state that today i.e. on 30.12.21 at 20.10 hrs I received a secret source information that one person namely Alok Sarkar of Vill- Jhakuapara, PO- Pandapara Kalibari, PS- Kotwali, Dist.- Jalpaiguri is selling ID liquor illegally in a hotel styled as Ma Hotel situated at Hotel Line, NJP under PS- NJP, Dist.- Jalpaiguri for his illegal gain. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No 1924 dated 30.12.21 and informed the fact to you. As per your kind direction and instruction myself along with HG/794 Ranjit Roy, CV/824 Niru Kr Yadav both of NJP PS, SPC left for Hotel Line to work out the information in hand. At about 20.25 hrs we arrived at Ma hotel and held raid and managed to apprehended him. On being asked he disclosed his name and identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered at his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between hrs 20.45 hrs to 21.35 hrs on 30.12.21.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Alok Sarkar (62 yrs) S/O late Manoranjan Sarkar of Vill- Jhakuapara, PO- Pandapara Kalibari, PS- Kotwali, Dist.- Jalpaiguri and arrange for its investigation.
