In producing herewith one accused person namely Dilip Ch. Barman (52yrs) S/o. Lt. Ramesh Ch. Barman of Bhola More, Jamurivita, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri along with the following seized articles as per proper seizure list:


1. Nine(09) Bottles of Himalayan Gold 60 up country spirit each bottle containing 600ML.
2. Five (05) Bottles of Galaxy Boss 60 up Country spirit each bottle containing 300ML.
3. Two(02) Bottles of MC. Dowells No. 01 Rum 180 ML each.
4. One nylon bag which used to carry the above noted articles.

I, SI. Rakesh Debnath of Ambari Falakata out post under NJP PS/SPC lodged a written complainant against the above noted person to the effect that today on 30.12.2021 at 19:45hrs received a source information from Sahudangi more has gathered huge amount of liquor illegally for selling the same in the customer for his wrongful gain. This refers to Ambari Falakata Out Post GDE No1448 dated 30.12.21. I informed to O/C Ambari Falakata out post about the information. As per his kind instruction I along with, (1) ASI. Sailendra Singh (2) C/1180 Susen Roy and (3)NVP 130 Dhanadeb Roy proceed to Sahudangi more to work out the information. At 19:55 hrs we reached at the spot, sometimes after being identified by the source our police party held raid at Sahudangi More and recovered the above noted articles from the possession of above noted accused person namely Dilip Ch. Barman (52yrs) S/o. Lt. Ramesh Ch. Barman of Bhola More, Jamurivita, PO-Sahudangi Hat, PS-NJP Dist- Jalpaiguri. On demand he could not produce any valid license/documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sell the same in the customer since long for his wrongful gain. In presence of witnesses namely 1) Abhijit Majumder S/o. Lt. Ashim Majumder of Chakiavita, PO. Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o. Lt. Narayan Sarkar of Ambari Falakata, PO. Kamarvita, PS. NJP, Dist-Jalpaiguri. I seized the above noted articles from the possession of above noted accused person after preparing proper seizure list and took signature of the accused person and witnesses. The seizure was made between 20.35 hrs to 20:45 hrs. I arrested the said person u/s 41 Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.


