Respected Sir,

I JayPrakash Ram, son of Megan Ram working as a manager of Zil Power & Electrical Pvt. Ltd. from the year of 2020 to till dated. today at about I have received the mobile call from our staff Mr. Parag Thakur, who is residing the factory quarter along with family, give me a call at about around 2:00 AM and informing me regarding the massive and great theft to place in our factory and fire breakout in the office of the factory, which comes to the knowledge of Parag's wife at about around 2:00AM while her wife come out for urination.

She have found that the light of car is blinking and car pickup both vehicle is misplaced and she imminently informed her husband. She called her husband and Parag called the other staff Madan Lal in our premises, they along with torch light and stick went toward the factory the 1<sup>st</sup> floor shutter was partially opened and the apparent that something going wrong and the total factory inside light switch off and also they have found the key of pickup in ground.

Mr. Parag and Bapi Das called to Bijay Das unfortunately his cell phone was switch off, then he called to Amarjeet Das, son of Bijay Das and Bandana Das. Entire thing narrate before them over on mobile, they have arrive in the factory with few neighbors by that time I also being reached the factory.

Altogether we have open the shutter of ground floor and found all the materials are being unorganized and the smoke is come out from the office and everybody engaged to controlled smoke and fire. Bijay Das informed the police station & fire bridged also.

While we have searching the Almirah of the office it was found broken along with the office door too. The amount Rs. 3.50 Lakhs (Rupees Three Lakhs Fifty Thousand) which was kept in the Almirah in the box was missing and the all-important document of the factory are being under the fire. After that we are found copper wire, copper lug & other raw materials are being theft and including damage value approx. Rs. 25, 00,000/- (Twenty Five Lakhs)

Sir we apprehend that the operation of theft was take such manner assuming us the information of each and everything are with culprits about door and key and stocks and cashes also.
