that- on 03/01/22 ASG/ Sanjit Datta H.G/1184, Bipul Roy
H.G/1163, Prabir Roy, cr-276, Bivash Kewal, cr-995.
Sanjit Roy were on night duty at Balason
traffic out-post, where H.G/ Bipul Roy & H.G/P. Roy
both were on night duty at Balason T.O.P
Khaprail side, both civic volunteers were engaged
for light signal control duty in the tower
at Balason T.O.P & ASG/ Sanjit Datta along with
one signal operator civic volunteer on duty at
Palpara side, on 03/01/22 night at about 23:45
hrs H.G/ Bipul Roy & H.G/ Prabir Roy saw the moving
or loaded heavy vehicle waiting on the side
of Khaprail side to go towards Balason Bailey
bridge, Hence both duty H.G's were tried to stop the
car to stop going towards the Balason Bailey
bridge and they also informed the vehicle driver
that they have taken their car by another
road and bailey bridge would be harmed if-
they run through the bailey bridge by a loaded
heavy vehicle. Hence the vehicle driver & staff
were hit the H.G boy and forcibly brought
their car over the bailey bridge and also
vehicle driver also tried to kill the H.G boy
by pushing them under the car. At that time
due to the heavy speed of the offending vehicle
barriers of the road were splattered by the
impact velocity of the vehicle & damaged the
road side barriers of the road.


So, I pray to your kind honour kindly take appropriate legal action against the driver of the offending vehicle w. P.B.G.2 C.R./4648
