Informed O/C, Matigara PS and as per his direction, I along with force had been to Chathat Medical More under NBMC & Hospital OP and arrested the above noted accused person. Thereby completely violating the lockdown measures issued by Chief Secretary West Bengal vide order no. 753/XV II-ISS/2M-22/2020 DTD.02/01/2022. On seeing police, he tried to flee away but somehow, the above noted person could be apprehended. On interrogation, he disclosed his name and address as noted above.
