I,SI Pranab Kumar Singh of New Jalpaiguri Police Station, SPC do here by lodged this written complaint against the above noted persons to the effect that today (03/01/22) in between 20:45 Hrs and 21:15 Hrs in course of performing mobile van duty I along with force went to Netaji More ,PS- NJP , Jalpaiguri and found (i)Md Alam (26yrs) s/o Lt. Md. Kaimul of Rajahali ,PS- NJP Dist- Paswan both of vill- Gatta Tala ,PS+Dist- Kathihar(iv)Prasanjit saha (32yrs) s/o Upendra of Sukantapally ,PS-NJP Dist- Jalpaiguri (v)Pawan sarkar(19yrs) s/o Lt. Palash Sarkarof Ambika Nagar ,PS- NJP Dist- Jalpaiguri (vi) Krishna Kumar Yadav (19yrs) s/o Alhak Yadav of vill Hriday Ganj ,PS- Sahek Dist-Kathihar (vii) Rohit Kumar (20yrs) s/o Ajay Kumar Yadav of vill Hriday Sahek Dist- Kathihar Bihar (viii) Ganesh Kumar (19yrs) s/o Sanjay Ghosh of vii- Barmalia PS- Dist- Kathihar Bihar and found that the above noted persons were gathered there without any reason and found them without wearing mask and also making unnecessary gathering at to Netaji More . On interrogation they also stated that they were well aware of Govt. order regarding pandemic situations and wearing of facemasks was mandatory in public places in the current pandemic situation.

They all are violated the order of Govt. of West Bengal vide order No 753/XVII-ISS/2M-2/2020 Dated 02/01/2022 regarding pandemic situations.. Hence, I arrested them under proper memo of arrest in between 20:45 Hrs and 21:15 Hrs and duly signed by them in presence of witnesses and inform the ground of arrest.

Hence, I, request you for starting a specific case U/S 188/269/270 IPC r/w sec 51 (b) of disaster Management Act.2005 against the above noted accused persons and arrange proper investigation on the case.
