I, Wajid Ali, Son of Md. Tayeb Ali, resident of Prakash Nagar, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against Aman Ali, Son of Not Known, permanent resident of permanent resident of Belakoba, P.O. & P.S. Belakoba, Dist. Jalpaiguri, presently residing at Isckon Raod, Ward No.41 of S.M.C, P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri to the effect that on 31-12-2021 at about 11:30 P.M. near Victoria Junction building at 2nd Mile, Sevoke Road within the jurisdiction of Bhaktinagar P.S., said Aman Khan assaulted me with iron punch wearing on his knuckles, I resisted and ran away to save my life and sat inside the Alto-800 car bearing registration No.WB74N3149 of my friend to run away to save from his attack, said Aman Khan took out sword from his vehicle bearing Registration No.WB-74AL-1500 and he attacked me with an intention to kill me but fortunately the sword strike on the front glass and body of the said car of my friend's vehicle and when out of his fear, we were proceeding fast with the said car to save my life, said Aman Khan chased us with his aforesaid vehicle and somehow I saved my life. Said Aman Khan attacked me with iron punch and sword with an intention to kill me but fortunately, my life has been saved from him.
