Respected Sir,

I, **Smt. Bhaktimaya Roy (Thapa) @ Geeta Chhetri Nee Roy**, Wife of Sri Biswajit Roy and daughter of Sri Jan Bahadur Thapa, residing at Sevoke Bazar, P.O. Kalijhora, P.S. Kurseong, Dist. Darjeeling, do hereby lodge a complaint against my husband, Biswajit Roy, Son of Elen Roy, 2) Elen Roy (Father-in-law), 3) Smt. Lakhi Roy (Mother-in-law), 4) Bishali, Second wife of my husband, Biswajit Roy, all are residing at East Salugara, Ward No.42 of S.M.C., P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, to the effects as follows:-

- (1) That my marriage was solemnized on 16-08-2008 along with abovenamed Biswajit Roy as per Hindu rites, rituals and customs and subsequently the said marriage was registered under Section 8 of the Hindu Marriage Act, 1955 and the marriage certificate was issued by the competent authority and we had/has been living at my matrimonial house as husband and wife.
- (2) That out of the said wed-lock, I gave birth to a male baby on 01-08-2013 who is at present 8 years old and studying at Class-III at Kendriya Vidhyalaya.
- (3) That since last 3 years my husband had/has been continuously abusing in filthy languages and committing mental and physical torture upon me and my father-in-law and mother-in-law aids and abets my husband in committing the same upon me for the reason that my husband had/has an extra-marital relationship with the lady named, Bishali and subsequently in the month of March, 2021 my husband married the said lady and my father-in-law and mother-in-law and said lady aided and abetted my husband in the said marriage knowing fully well that my husband has not divorced me and still I am alive. My husband and the said lady started cohabitating as husband and wife at the rented house.

- (5) That my husband and my in-laws inspite of making several request has not been allowing to talk to my minor son and also not allowing me to meet him inspite of his willingness. My husband and my in-laws have restrained and confined my minor son at my matrimonial house.
- (6) That I tolerated above stated mental and physical abuses upon me by my husband and in-laws but I did not lodge any complaint against them with the police authority hoping everything will be peaceful after elapse of time and shall lead a happy conjugal life but all went in vain.

So, therefore, I humbly request you take appropriate legal action against my husband, my in-laws and the aforesaid lady and booked them under specific provision of law at an earliest.
