Sir,

In producing herewith one accused person namely Kalimohan Roy (25), S/O- Kalthu Roy of Hansuapara, Bhelacoba PS Rajganj Dist. Jalpaiguri. Present address- Chiramill Ektiasal PS Bhaktinagar Dist. Jalpaiguri and the following articles under seizure:

(1) 16 (Sixteen) bottles of "HIMALAYAN GOLD PREMIUM 60 UP COUNTRY SPIRIT" each bottle containing 600 ML, MRP Rs.120/- (Total- 9.6 Liter & Amount Rs 1920/-).

I SI Pradip Kr Singha of Ashighar OP PS Bhaktinagar lodged a written complaint against the accused person namely Kalimohan Roy (25), S/O- Kalthu Roy of Hansuapara, Bhelacoba PS Rajganj Dist. Jalpaiguri, Present address- Chiramill Ektiasal PS Bhaktinagar Dist. Jalpaiguri to the effect that, on 02.01.2022 evening as per order of O/C Ashighar OP I along with ASI Ujjal Mandal C/ 877 Munna Ahmed and CV/1016 Amrit Roy, all of Ashighar OP with Govt. vehicle no WB42/R 8829 were holding raid against anti social elem ents, warrentees, ID liquor etc in different area under Ashigharh OP as per order vide Ashighar OP GDE no. 34 Dt 02.01.2022 in course of which I received information from my source that one Kalimohan Roy stored a huge numbers of bottles of liquor inside his temporary shop at Chiramill Ektiasal and used to sell to the local youth in higher rates. I immediately informed O/C Ashighar OP and as per his kind direction wasting no time I along with my accompanied party left for Chiramill Ektiasal area to verify the veracity of information. On the way I called two local persons namely (1) Dilip Das (37) S/O Kall Charan Das of Ghogomall PS Bhaktinagar Dist Jalpaiguri and (2) Ajay Sarkar (31) S/O Sunil Sarkar of Niranan Nagar W/no.36 PS Bhaktinagar Dist. Jalpaiguri to accompany us to witness the search and seizure if required. On reaching at Chiramill Ektiasal area as indicated by my source I held raid at the temporary shop of Kalimohan Roy at Chiramill Ektiasal. But seeing us the above noted accused person tried to flee away from the spot, but we managed to apprehend him. I searched in the temporary shop of above noted accused person, in course of which I recovered the above noted bottles of liquor from inside his temporary shop. I seized the above noted articles as alamath of the case, as the above noted person as well as none could be able to produce any documents for such illegal possession of such articles. I also arrest the above noted accused person for violating the provision of B.E Act. The Search and seizure and arrest were made in between 21.35 hrs and 21.55 hrs on 02.01.2022

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused persons Kalimohan Roy (25), S/O- Kalthu Roy of Hansuapara, Bhelacoba PS Rajganj Dist. Jalpaiguri, Present address- Chiramill Ektiasal PS Bhaktinagar Dist. Jalpaiguri and arrange for its investigation.
