This is to inform you that I Sri Soumyadeep Ganguly S/O Sri Sibnath Ganguly posted as Assistant Engineer in Siliguri Town Division (W.B.S.E.D.C.L) would like to lodge a complaint against the above mentioned vehicle for damaging the assets of our department near 7th Mile, Sevoke Road. As reported by the HT Outsourced maintenance gang of Housing Board Sub-Station, the vehicle has crashed with an 8mtr PCC pole thereby damaging the pole leading to a loss of Rs. /-11442.00 (approx.) & causing interruption in power. The information of the incident reached at Housing Board Substation on 03.01.2022 at around 09.00 am from LT Mobile Van of Power House CCC.
